



Investment Overview

The Rain & Co. Salon Building is ideally located just south of the hard corner of West Meeker Street and 2nd Avenue South in the city of Kent, WA. The property is situated in a densely populated commercial corridor in the heart of downtown Kent. The location is surrounded by a vibrant mix of national retailers, mom-and-pop shops, multi-family apartment complexes, City of Kent government buildings, and is in close proximity to the ShoWare Center.

The Rain & Co. Salon Building is comprised of a 3,534 square foot, two-story commercial building, situated on 2,027 square feet of land zoned DCE. The first floor has a fully updated salon build-out and is owner-occupied by Rain & Co. Salon. There is potential for this unit to be delivered vacant, making this a great opportunity for an owner-user buyer to occupy the building. The salon unit includes nine separate hairstylist stations, which can be leased individually by a salon operator. Current rents are \$750/month per station. There's also the opportunity to lease the unit's skincare/treatment room for additional rental income.

The second floor is occupied by a Pilates studio on a one year lease, with an additional one-year option to extend. This unit has a beautiful studio/spa build-out, which includes a lobby area, studio space, two massages rooms, and a break room.

The subject property underwent significant renovation in 2005. Total renovation costs exceeded \$430,000.

The Rain & Co. Salon Building offers a business owner or investor the opportunity to own a fully updated personal care services building in a prime Kent location.




