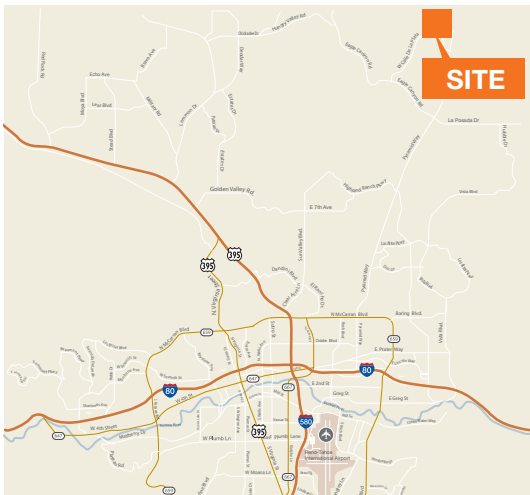




## Spanish Springs Business Center Sparks, NV

Spanish Springs Business Center is completely self-equipped with an ESFR ready sprinkler system (see website download section for specifications)

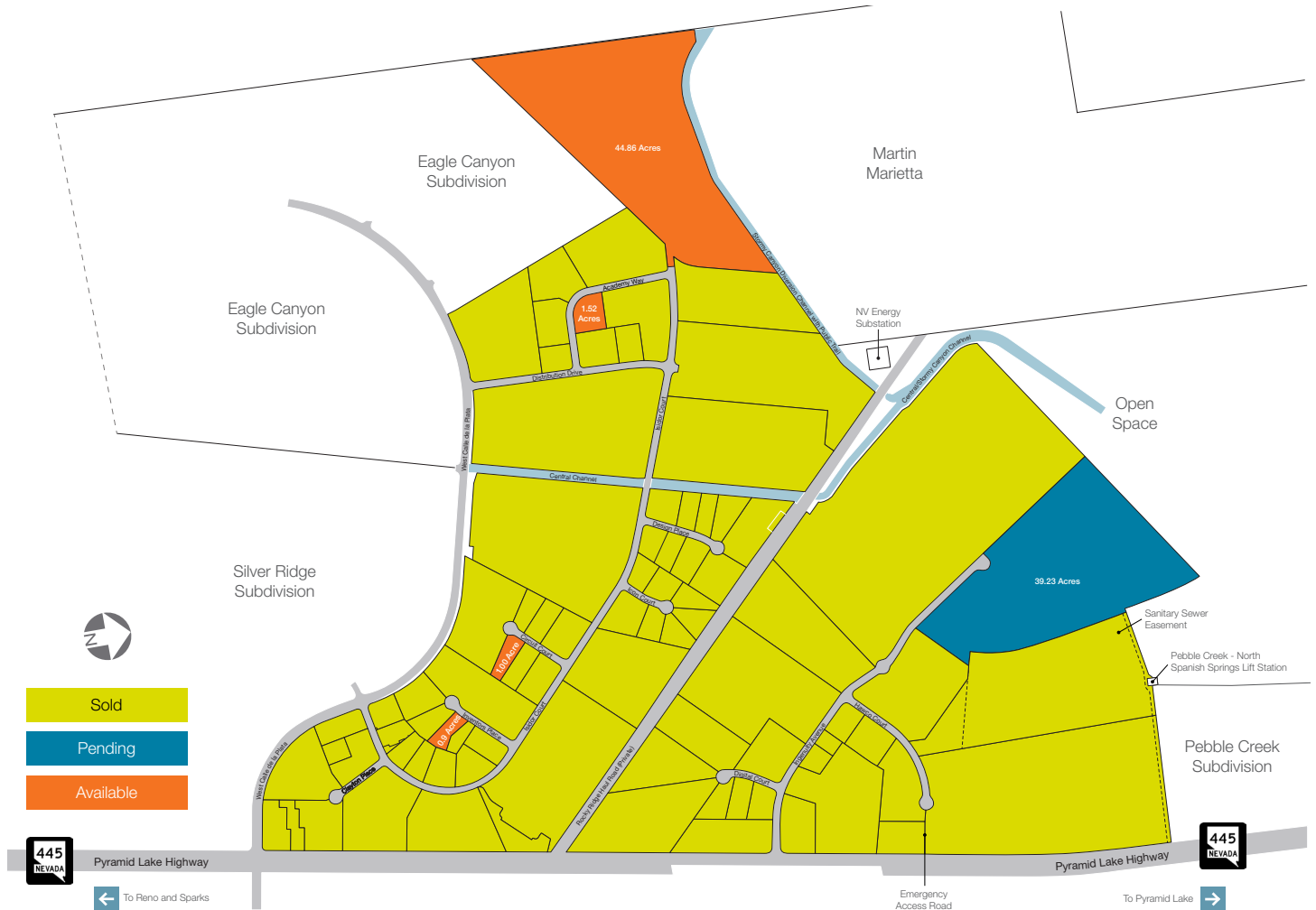

All utilities - power, gas, water, sewer, telephone, etc. - are already located in the streets and there is an electrical substation in the park
