

### ABOUT HAPPY JOES



Happy Joe's Pizza & Ice Cream Parlor is an American pizza parlor chain based in Bettendorf, Iowa. The restaurant chain was founded in 1972 by Lawrence Joseph "Happy Joe" Whitty, a former Shakey's Pizza manager. Its 50 restaurants are mostly located in the Midwestern United States (in Iowa, Illinois, Missouri, Minnesota, North Dakota and Wisconsin), although the company is also present in Arizona. The idea for Happy Joe's came from a combination of a pizza parlor and ice cream palace.

Happy Joe's claims to be the first pizza restaurant to offer a taco pizza (a pizza with refried bean/tomato sauce, cheese, lettuce, tomato and taco chips). After a franchisee suggested adding tacos to the menu, Whitty invented the restaurant's best-selling product, the Taco Pizza. In 2005, Happy Joe's started offering breakfast pizzas at select locations. In 2013, Happy Joe's started offering flatbread pizzas. It also features outlandish birthday parties.
