Montville Township

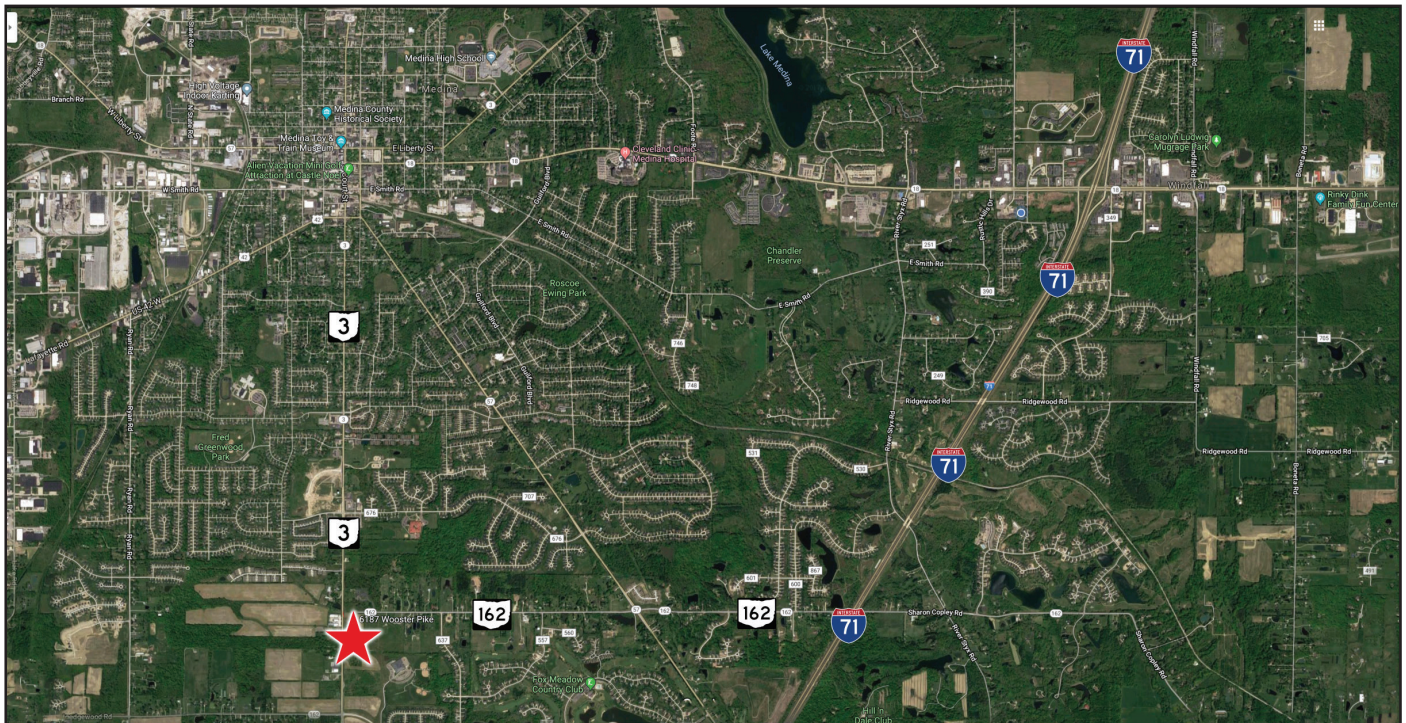
It is a wonderful place to live, and a great place to do business.
