The property is included in Eastlake TOD. Master Plan. The Eastlake TOD is a transit stop on the North Metro Line that originates in Denver's Union Station. The North Metro Line is scheduled to be completed in January 2018. The light rail station at 124th Avenue will be located only 1/2 mile south.

Potential Residential Rezoning:

The property is located in a primarily residential neighborhood across the street from the Adams County Education Support Building and is located due south of the Adams County Century Middle School. The property has many attributes that would make it a prime, higher-density residential development. The northern boundary of the property borders and has access to the beautifully tree-lined Signal Ditch Bike/Walking Path. This Path goes south to the Thorncreek Shopping Center (approximately one mile), featuring a Super Target, and also east to Lake Village Park (less than one mile). From there the Path goes north and south for several miles. The Path also connects behind the property to the athletic fields of Century Middle School.
