MADE THE day of August in the year of our lord two thousand fifteen (2015)

BETVEEN MERRILL R. SHAFFER and DEBORAH K. SHAFFER, formerly DEBORAH K. NALE, husband and wife, both Walker Township, Juniata County, Pennsylvania, of the First Part,

AND MERRILL R. SHAFFER and DEBORAH K. SHAFFER, husband and wife, as tenants by the errireties, of the Second Part,

Grantees

WITNESSETH, that in consideration of One and 00/100 (\$1.00) Dollar, in hand paid, the receipt whereof is hereby acknowledged, the said grantors do hereby grant and convey to the said grantees, as tenants by the entireties, with the right and incidence of survivorship, their heirs and assigns,

TRACT 1: ALL THAT CERTAIN lot of ground, together with any and all improvements there on erected, situate in Delaware Township, Juniata County, Pennsylvania, bounded and described as follows, to wit:
