






Road Map

Sec. 7057, Title 17, (Public Health) Cal. Adm. Code

System Pressure: (a) Normal operating pressure at the service connection shall not be less than 26 pounds per square inch gauge (p.s.i.g.) nor more than 126 p.s.i.g., except that during periods of hourly maximum demand at the time of peak seasonal loads the pressure may be not less than 20 p.s.i.g. and that during periods of hourly minimum demand the pressure may be not more than 150 p.s.i.g. Variations in pressures under normal operation shall not exceed 50 percent of the average operating pressure. The average operating pressure shall be determined by computing the arithmetical average of at least 24 consecutive hourly pressure readings.

(b) In a water system supplying customers at widely varying elevations, the utility may furnish a service which does not comply with the foregoing pressure specifications. If the customer is fully advised of the conditions under which average service may be expected, and the customer's agreement is secured in writing.

(c) New water systems, or new pressure zones in existing water systems supplying customers at substantially constant stevation shall be designed to maintain an operating pressure at the service connection of not less than 35 p.a.i.g. nor greater han 100 p.a.i.g.
