North Greenwood

Greenwood is a neighborhood in north central Seattle defined by Aurora Avenue N (Highway 99) to the east, N 105th Street to the north, 9th Avenue NW to the west and N 75th Street to the south. This vibrant neighborhood community is known for its numerous restaurants, coffee houses, bars, and boutiques. Greenwood's prime location is well served by highways and bus lines, making for quick commutes to many of the region's top employers. Located 5.9 miles north of South Lake Union, Greenwood is just a short 17-minute drive by car or 30-minute bus ride. With the delivery of the Northgate Link Light Rail station (only minutes away) on the horizon, Greenwood will experience an immediate increase in connectivity. A trip from the Northgate Link Light Rail station to Westlake Station will only take 14 minutes. This light rail line will also connect riders to the University of Washington, Sea-Tac Airport and soon, the rail will extend over Lake Washington to the Fastside.

Greenwood Avenue N serves as a main transit corridor that also includes a mix of commercial businesses and properties, single-family homes, condominiums and apartments which combine to create its own unique neighborhood vibe.

The Greenwood Ave N & N 97th St bus stop is just down the street from 10528 Greenwood Ave N, and three major bus routes service this station. With over a dozen metro transit bus routes with regular nearby stops, Greenwood serves as a prime location for quick access to all major employers, yet more affordable than the urban core. The highly utilized Park and Ride in nearby Northgate, gives commuters easy access and further connects Greenwood to the rest of King County. Highway 99 and I-5 are the main arterials into downtown Seattle, a direct shot on either side of South Lake Union.

Greenwood is situated between several major Seattle parks, providing wonderful outdoor experiences for locals looking for a getaway in the city. Located to the northeast of the Greenwood neighborhood, is Carkeek Park which comprises over 216 acres including hiking trails, picnic areas and breathtaking views of Puget Sound and the Olympic Mountains. To the southeast, Green Lake Park is one of Seattle's busiest and beloved parks. Locals gather around the freshwater lake for a run, bike or jog along the 2.8-mile trail, games on the athletic fields and swimming or boating on the lake. Golden Gardens is a directly west of Greenwood on the Puget Sound and is most famous for the exceptional views of the Olympic Mountains.


