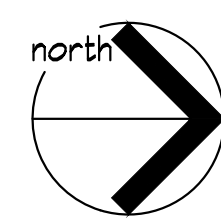
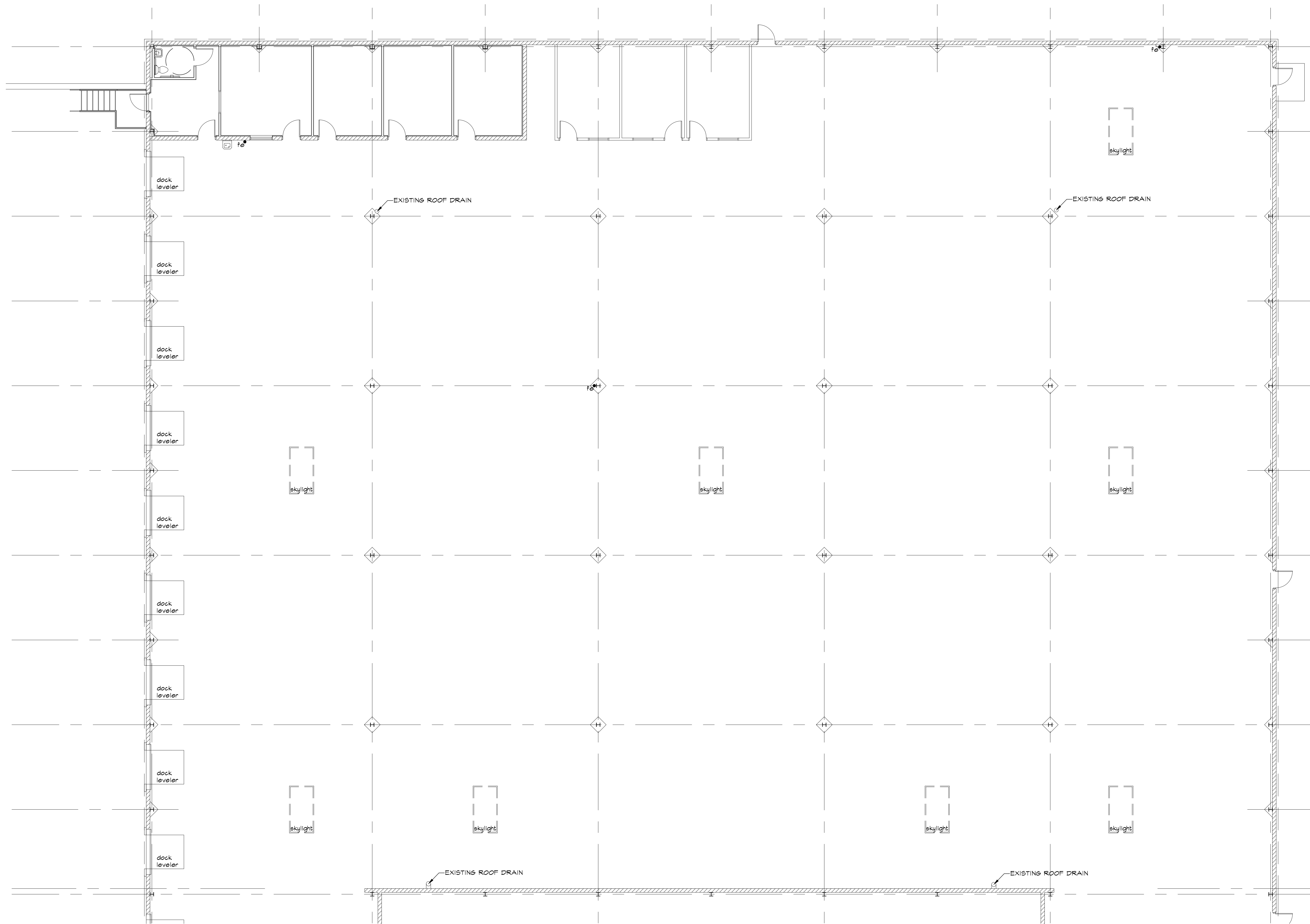

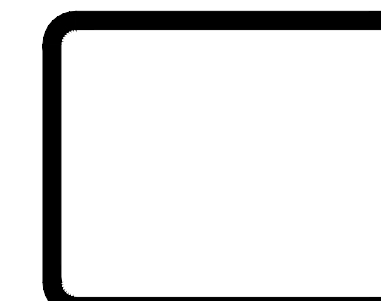


PARTIAL FIRST FLOOR PLAN

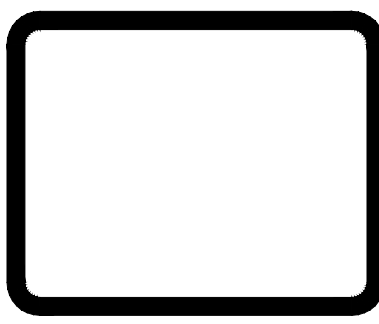


PARTIAL FIRST FLOOR PLAN

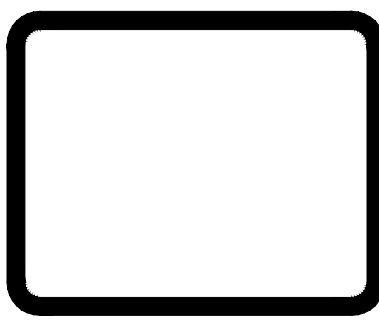
