Currently, 64.3% of the 44,025 housing units in the area are owner occupied; 26.5%, renter occupied; and 9.1% are vacant. Currently, in the U.S., 55.6% of the housing units in the area are owner occupied; 33.1% are renter occupied; and 11.3% are vacant. In 2010, there were 43,426 housing units in the area - 69.1% owner occupied, 24.0% renter occupied, and 6.9% vacant. The annual rate of change in housing units since 2010 is 0.61%. Median home value in the area is \$230,697, compared to a median home value of \$207,344 for the U.S. In five years, median value is projected to change by 4.53% annually to \$287,960.
