









Second Floor

Third Floor



THE NEIGHBORHOOD

MUSIC ROW/EDGEHILL

Situated southwest of downtown, Music Row is home to several businesses and attractions related to the city's musical heritage. Considered the heart of Nashville's entertainment industry, the Music Row area is centered on 16th and 17th Avenues South, which are known as Music Square East and West respectively. Points of interest in the district include the historic RCA Studio B, Columbia's Historic Quonset Hut, the first recording studio on Music Row, and Owen Bradley Park as well as numerous shops and upscale eateries. "Musica," a large bronze statue designed by Alan LeQuire, is the centerpiece of the Music Row Roundabout.

Edgehill is centrally located and loosely bordered by The Gulch on the north, 12 South on the south, Eighth Avenue on the east and Music Row on the west. Edgehill is also conveniently located near Vanderbilt and Belmont universities. Its ideal location has rejuvenated the community and attracted many for living and playing.

What Edgehill lacks in size it makes up in cool factor. The neighborhood anchor is Edgehill Village. Made up of brick buildings that once housed Whiteway Cleaners in the 1920s, Edgehill Village has been restored to embrace its historical style and significance. The village houses a carefully curated selection of restaurants, bars and shops.
