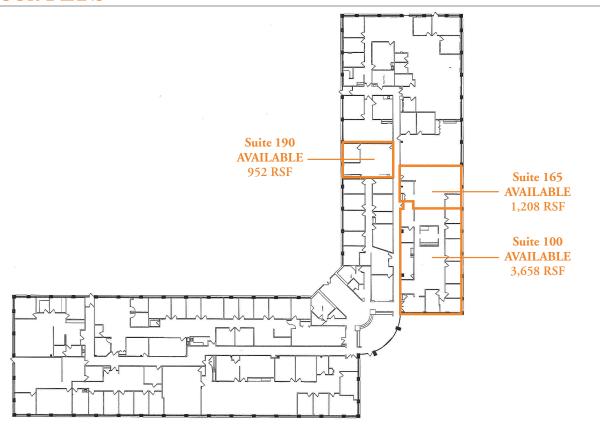








# FLOOR PLANS
