

A CERTAIN PIECE OR PORTION OF GROUND situated in Section 41, Township 8 South, Range 11 East, St. Tammany Parish, Louisiana, and more fully described as follows:

From the Section Corner common to Sections 40 and 41 at their convergence with the Township line between Townships 7 and 8, go South 48 degrees 45 minutes West 1022.0 feet to a 3/4-inch iron pipe and the point of beginning. From the point of beginning, go South 13 degrees 59 minutes East 459.12 feet (Title-433.14 feet) to an 1/2-inch iron rod located on the right descending bank of Chinchuba Creek; thence go along the right descending bank of Chinchuba Creek downstream North 65 degrees 01 minute 02 seconds West 18.94 feet; thence North 77 degrees 09 minutes 54 seconds West 65.92 feet; thence North 85 degrees 39 minutes 33 seconds West 40.2 feet; thence South 80 degrees 45 minutes 40 seconds West 21.19 feet; thence South 86 degrees 06 minutes 33 seconds West 47.55 feet; thence North 44 degrees 53 minutes 44 seconds West 25.10 feet; thence North 49 degrees 44 minutes 45 seconds West 76.95 feet; thence North 72 degrees 12 minutes 51 seconds West 80.65 feet; thence North 55 degrees 16 minutes 47 seconds West 65.0 feet; thence North 76 degrees 01 minute 55 seconds West 80.65 feet; thence South 81 degrees 39 minutes 18 seconds West 15.33 feet; thence South 34 degrees 59 minutes 23 seconds West 50.75 feet all along the right descending bank of Chinchuba Creek to an 1-inch iron pipe located on the easterly right-of-way line of U.S. Highway 190: thence North 04 degrees 45 minutes West 263.76 feet along the easterly right-of-way line of said highway to an 1/2-inch iron pipe; thence North 84 degrees 33 minutes 53 seconds East 464.5 feet to a 3/4-inch iron pipe and the point of beginning.

Said property contains 3.85 acres.

ST. TAMMANY PARISH, LOUISIANA.


