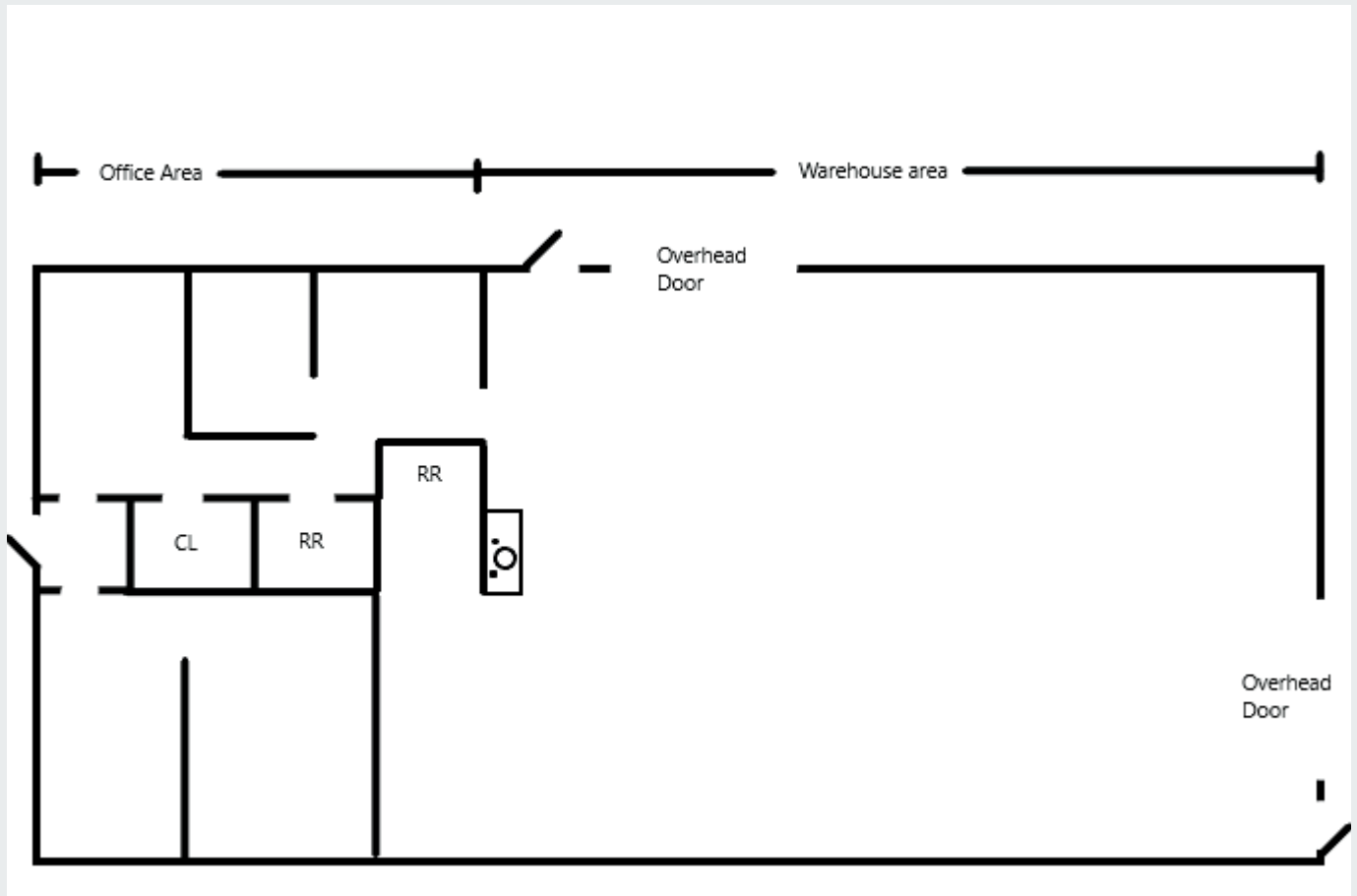

WAREHOUSE AREA

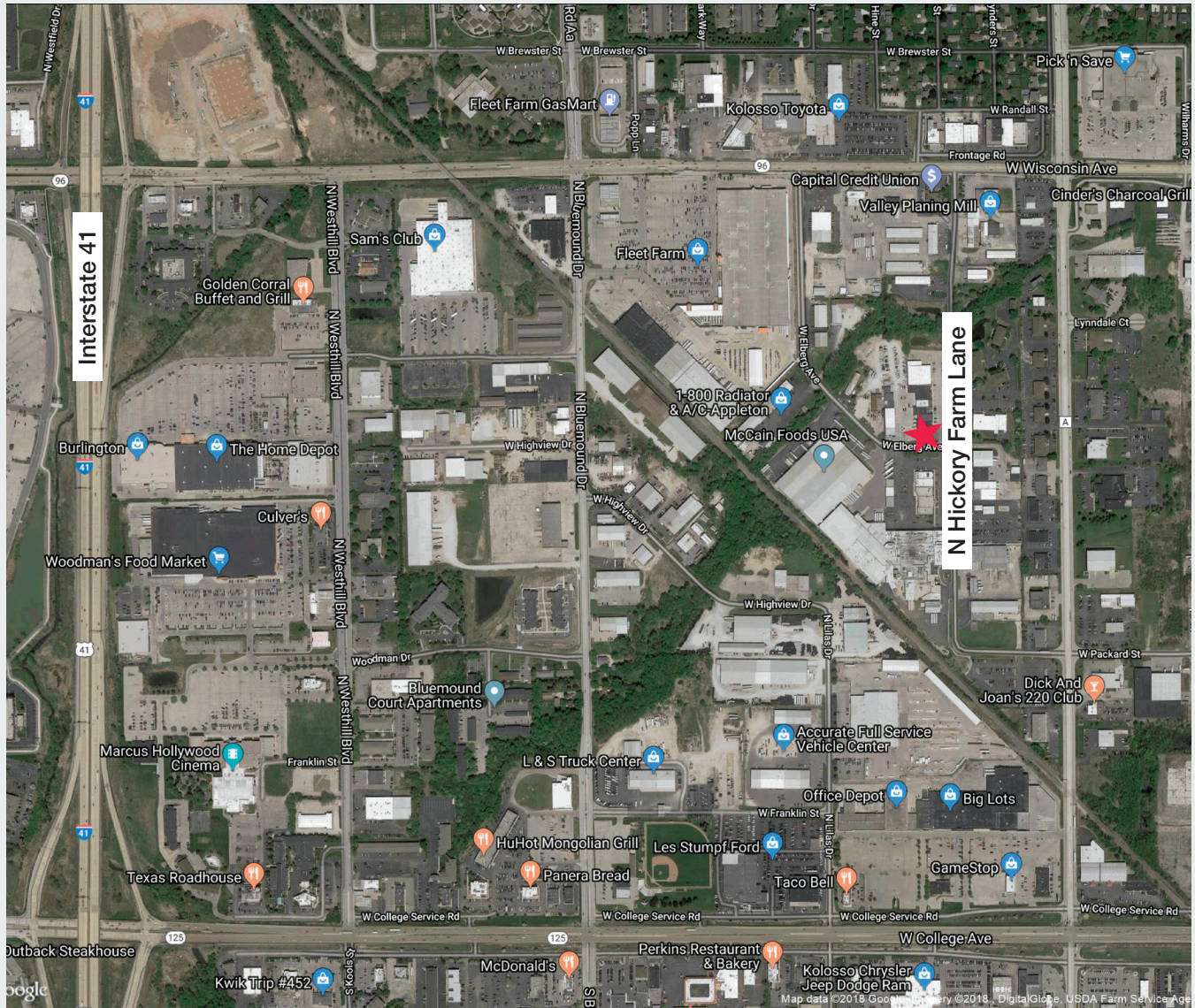
