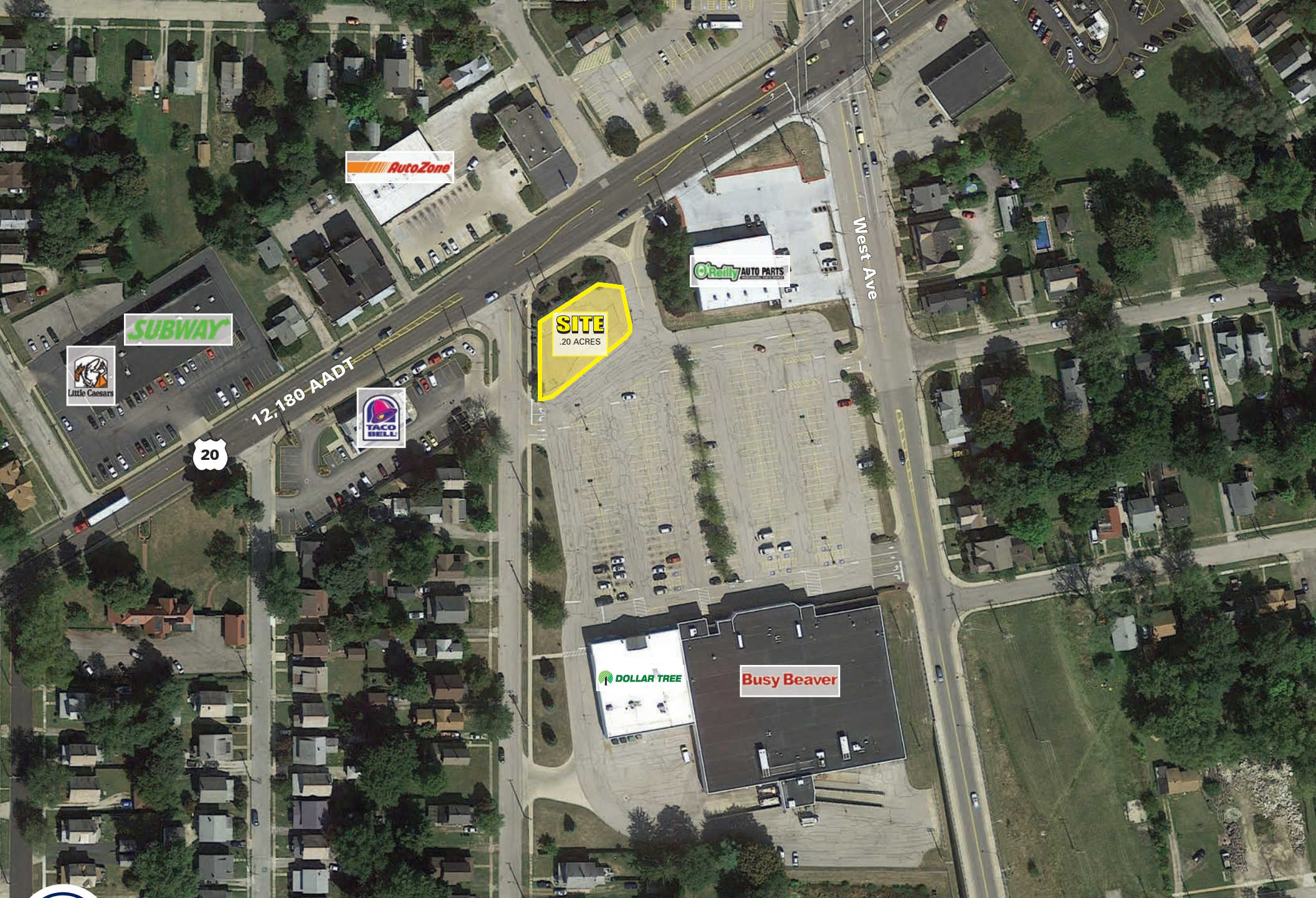

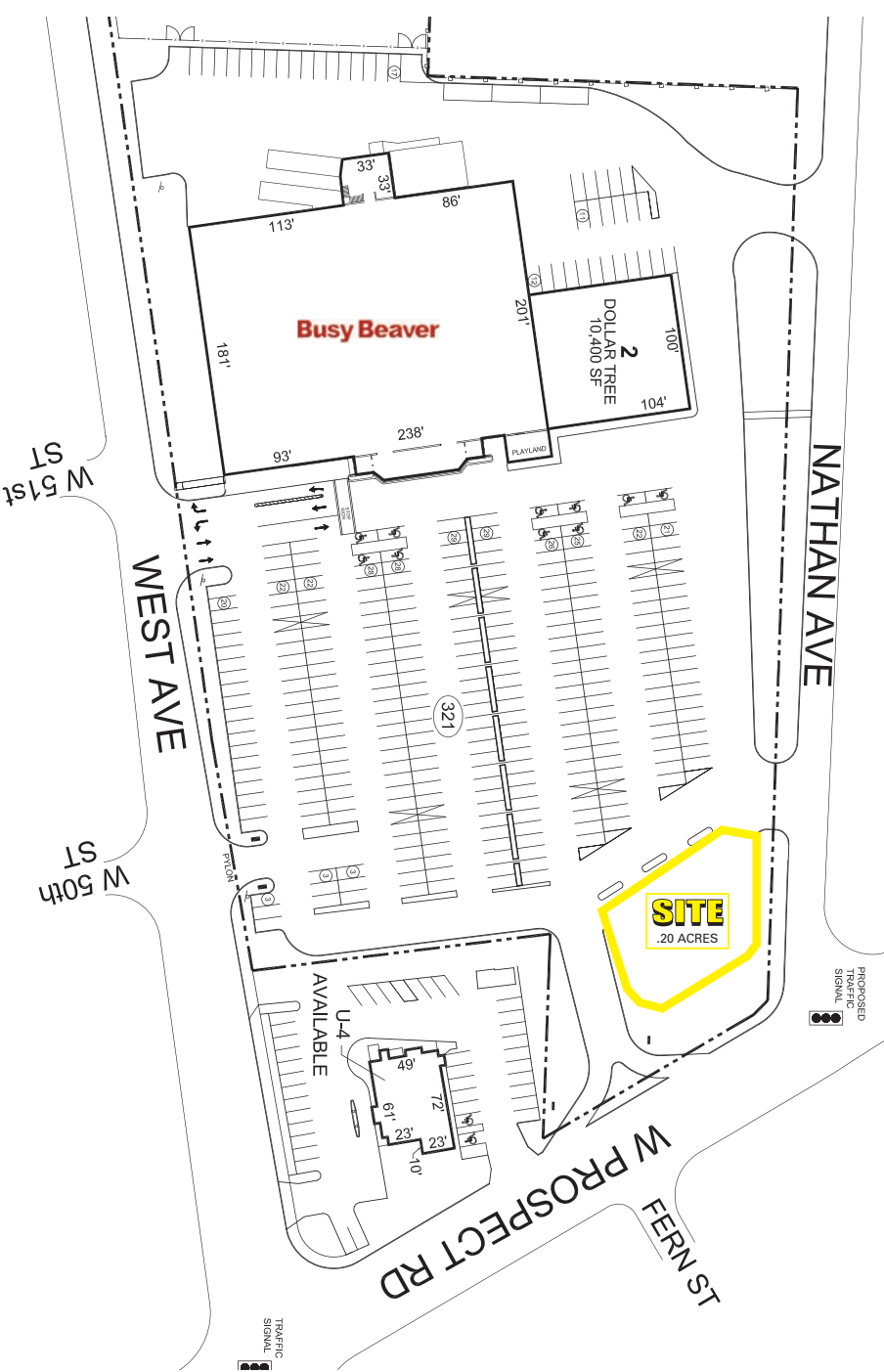
SITE AERIAL
