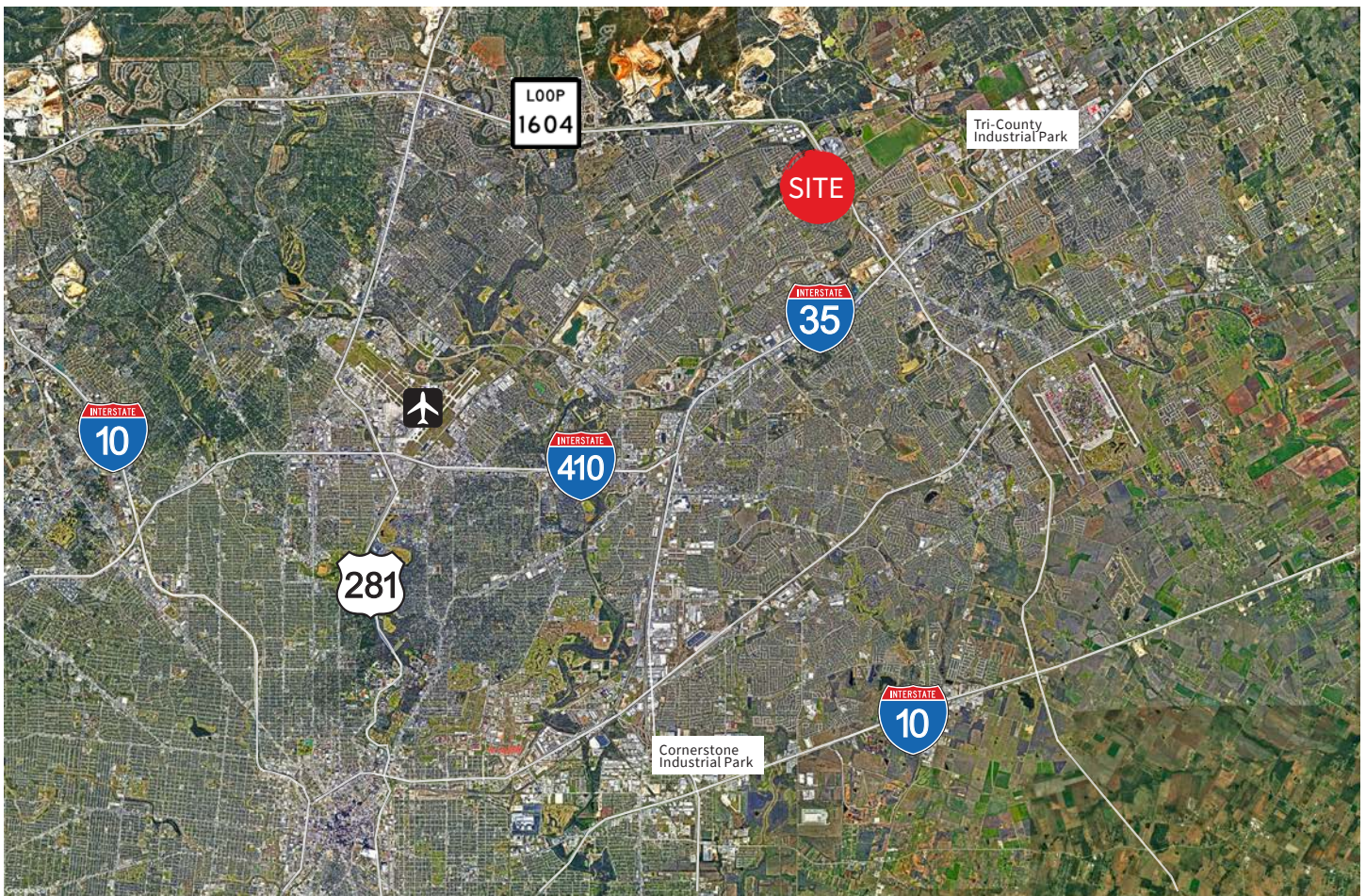

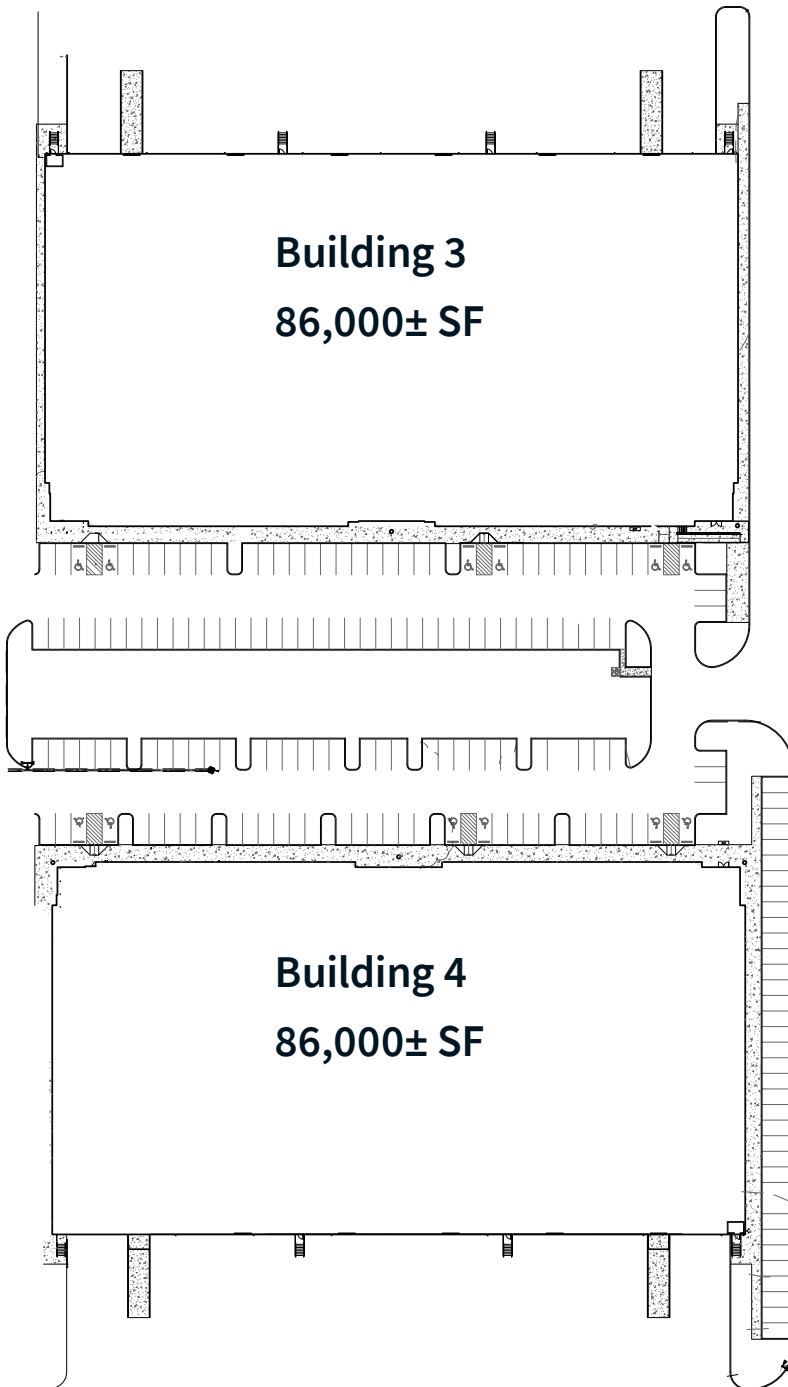

 - any confidential information or any other information that a party specifically instructs the broker in writing not to disclose, unless required to do so by law.
