





### PROPERTY OVERVIEW

Boston Commerce Center, located at 175 Campanelli Drive in Braintree, is a first class warehouse/manufacturing facility situated on ±24 acres within the Campanelli Industrial Park. Located 12 miles south of Boston, the site provides access to Boston's growing population as well as the intersections of Route 3, Interstate 93 and Route 128. Offering 484,000 square feet of warehouse space with 22' clear height, 59 loading docks and ample outside storage/parking area, the building can accommodate a wide range of users such as warehousing, manufacturing and R&D, among others.






