Greater Cincinnati is the headquarters city for various national and international companies such as American Financial Corporation, Duke Energy, The Kroger Company, Omnicare, Cincinnati Milacron, Procter & Gamble Company, Western-Southern Insurance, and more. The city is a world leader in production of machine tools, playing cards, soaps and detergents. 

The Company acquired 10 Jackson, MS area Taco Bells and in 1999 it purchased 24 Cincinnati locations.




