The opportunity is to purchase 78 acres located just east of U.S. 301/98 on Hightower Road in Dade City. The property is currently being used for cattle grazing. It features five homes and two wells (1-10" and 1-3"). Three of the homes are currently rented and provide income of \$40,000/year. Also, it's fenced and cross fenced.

A turning lane is being put in on US 301 at Pioneer Museum Road. Also, Pioneer Museum Road is going to be widened. Once completed, all traffic for the Dade City Business Center will enter and exit there.

It could be said that the future of this property would be best served as residential or industrial, though that is not the future land use. The Seller has had discussions with Dade City about possible annexation. The sites proximity to Dade City Business Center opens it up the opportunity for a rail spur (if desired by user). There's also potential to contract with Dade City Business Center for water and waste treatment.

LOCATION DESCRIPTION

The property is located at 15604 Hightower Drive, ust east of U.S. 301/98 in Dade City in unincorporated Pasco County. It's adjacent to Dade City Business Center and is in close proximity to I-75 (10+ minutes) and I-4 (30+ minutes).





Retailer Map











