

CONCEPTUAL RESTAURANT LAYOUT









The Location



More than 350,000 customers visit the MTS Transit store every year to purchase monthly passes, tickets, or get information. Sales exceed \$4.1 million. The MTS store sits at the base of the Mills Building located at 12th & Imperial across from the Petco Park. The 12th & Imperial station is a major transfer point between all of the San Diego trolley and bus lines, as it is the only station that is directly served by all four trolley lines.

MTS generates 92 million annual passenger trips or 310,000 each weekday. MTS' area of jurisdiction is about 570 square miles of the urbanized areas of San Diego County as well as the rural parts of East County, 3,240 total square miles, serving approximately 3 million people in San Diego County.


