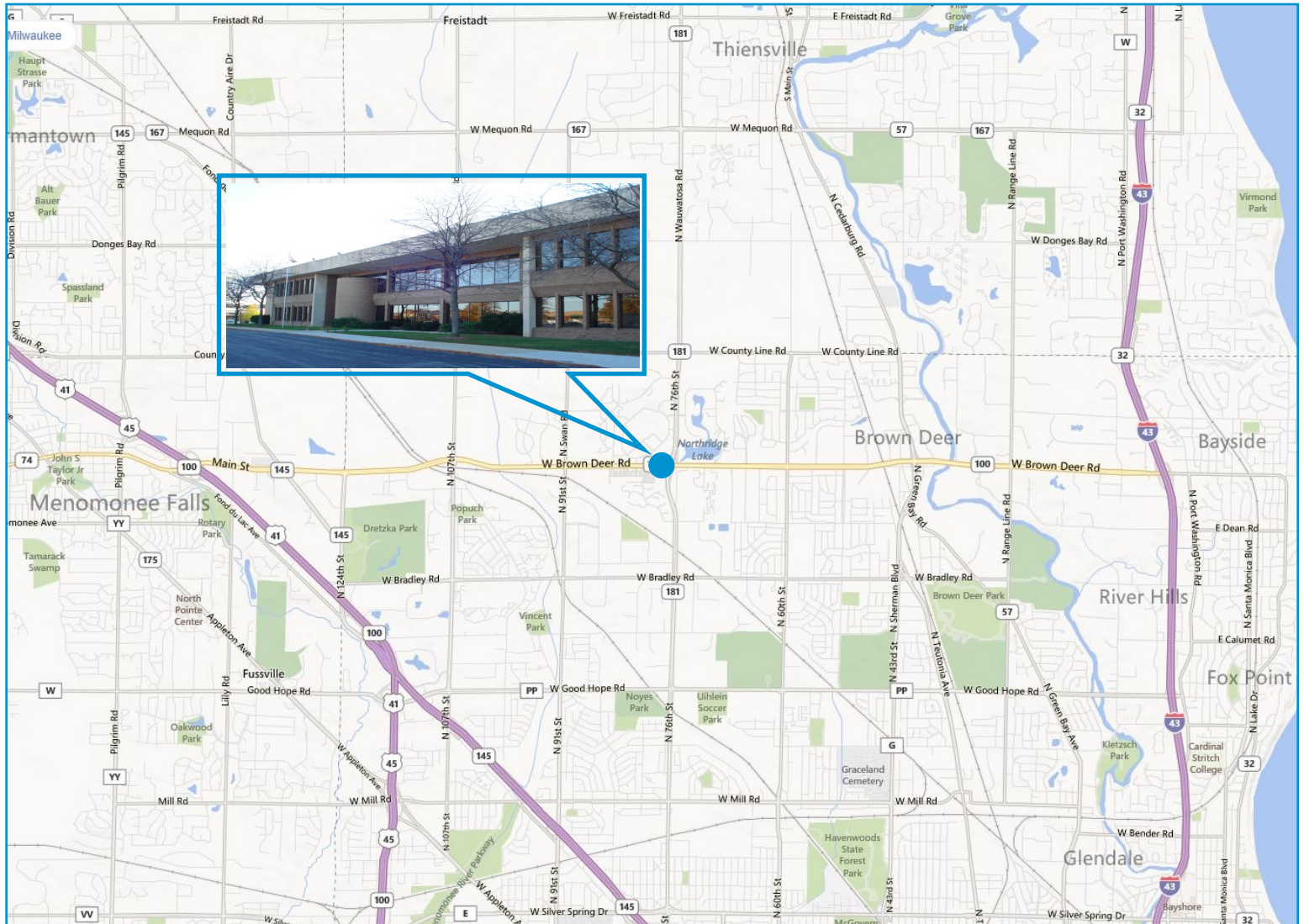

## Location Map



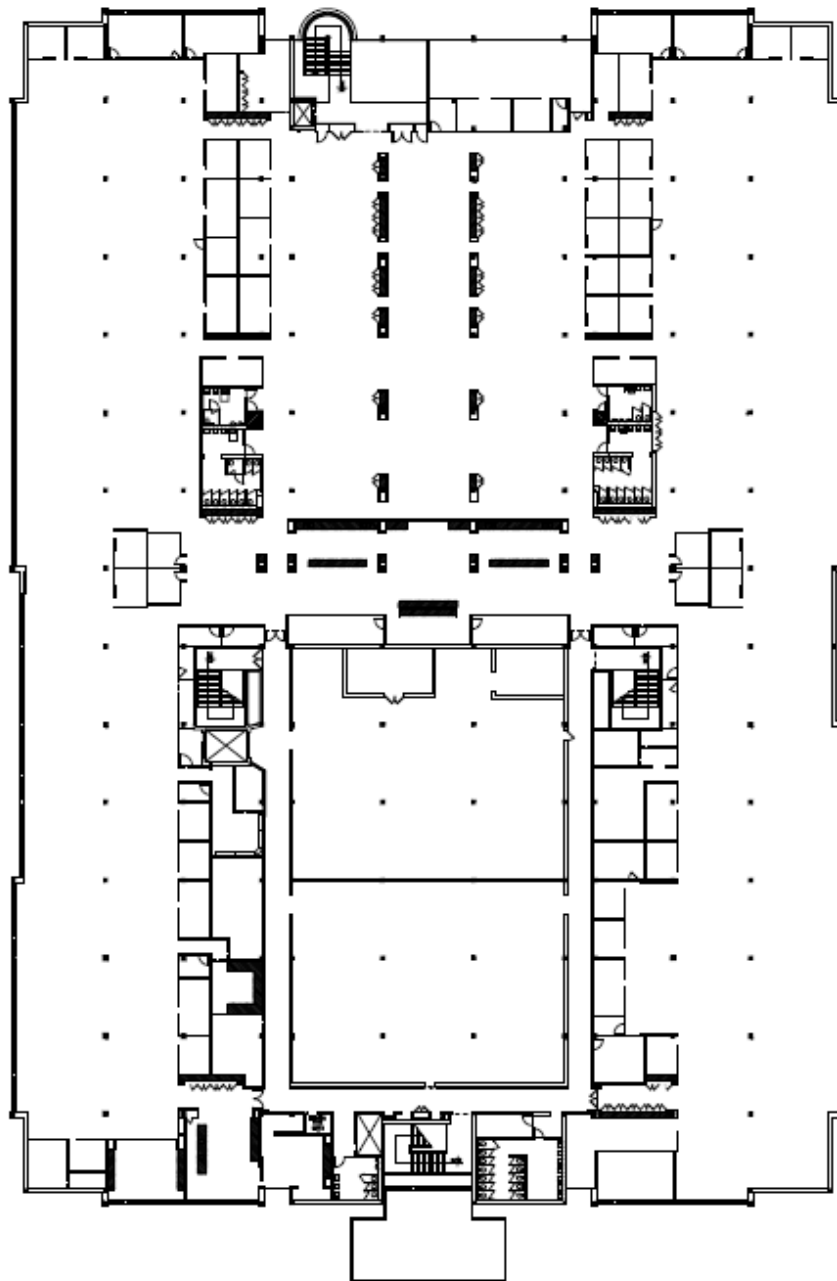

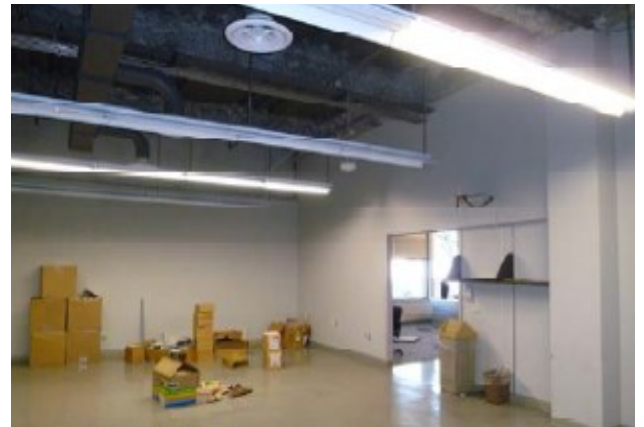
