- Lochinvar Hot Water System with Two (2) 200 Gallon Holding Tanks
- Oversized Shindler Elevator with Access to All Three Levels.

The current configuration includes four single & six double bedrooms with shared bathrooms, a large commercial kitchen that services the entire facility along with a staff break room with a kitchen and lockers, multiple lounges, a conference room, offices, and a laundry room with three commercial-grade stainless steel washers and dryers. On the first and second floors, there are bathrooms that provide large walk-in bathtubs and oversized showers. Entire facility has potential to be converted to a 10-unit 830-G housing development opportunity.

The 0.57 acre professionally landscaped property is located on a quiet street in a residential neighborhood. The property is minutes from I-95 Exit 63, the Clinton train station, shopping, restaurants, marina, and beach.
