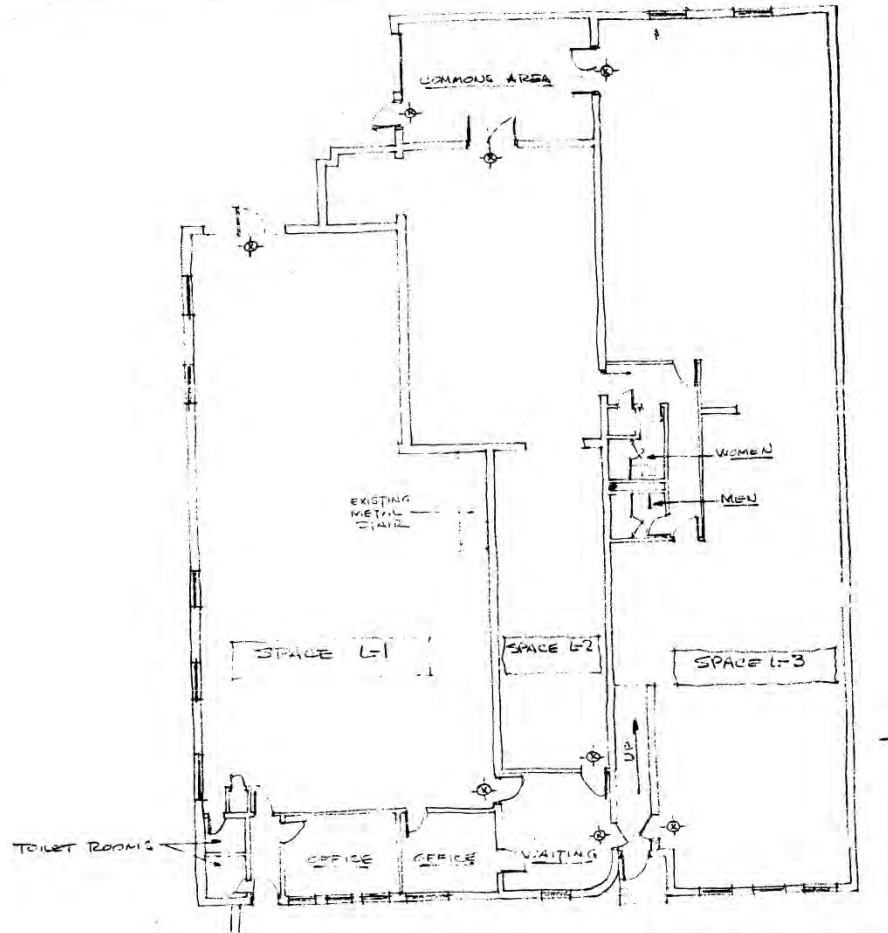

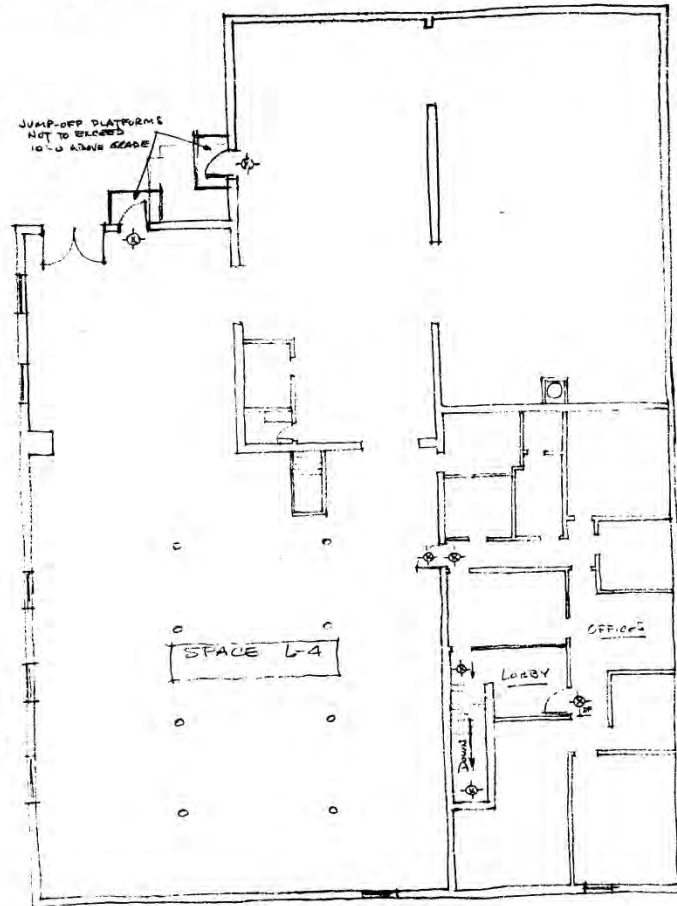

FIRST FLOOR PLAN SCALE 1/8" = 1'-0"



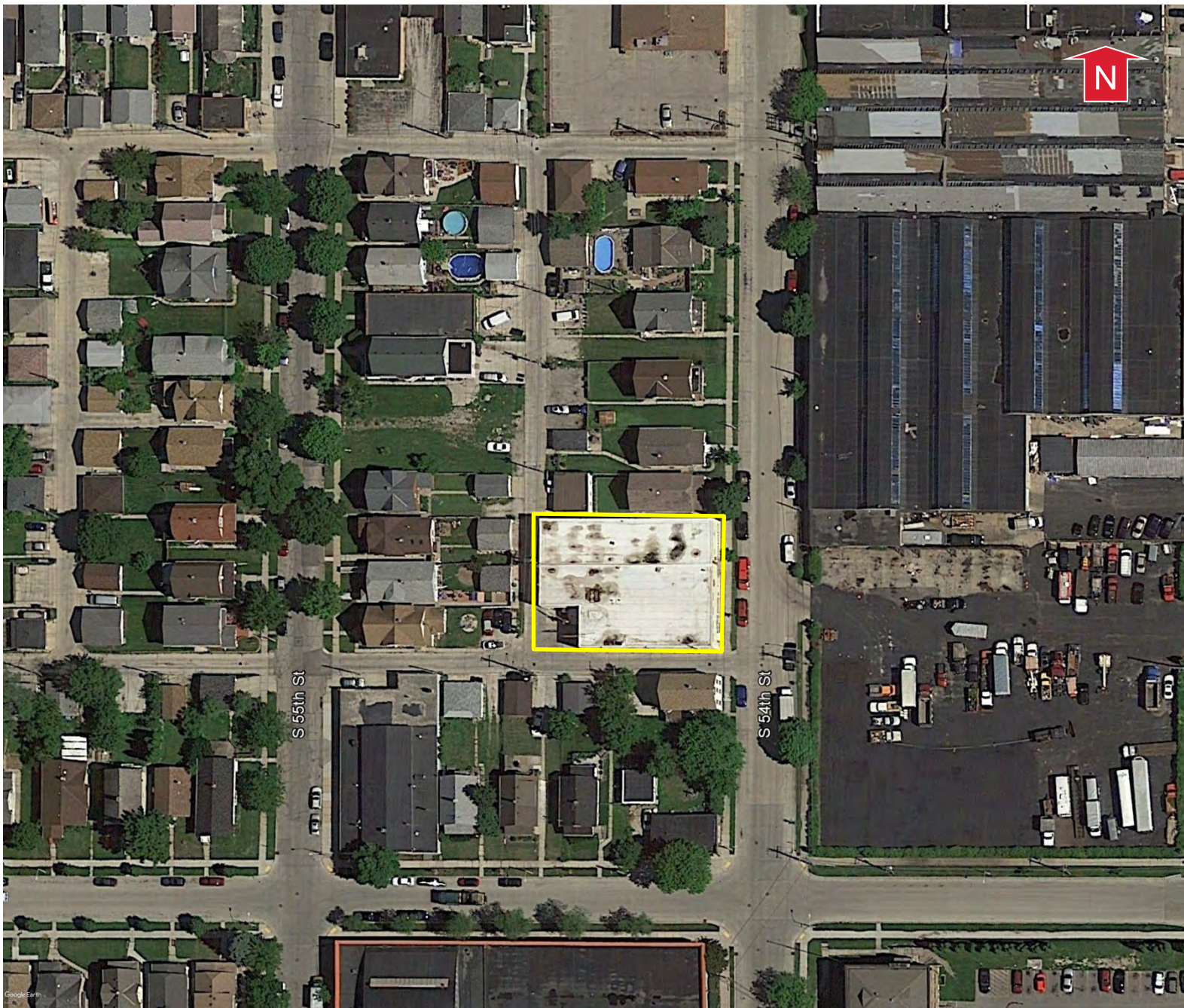
SECOND FLOOR PLAN SCALE 1/8" = 1'-0"

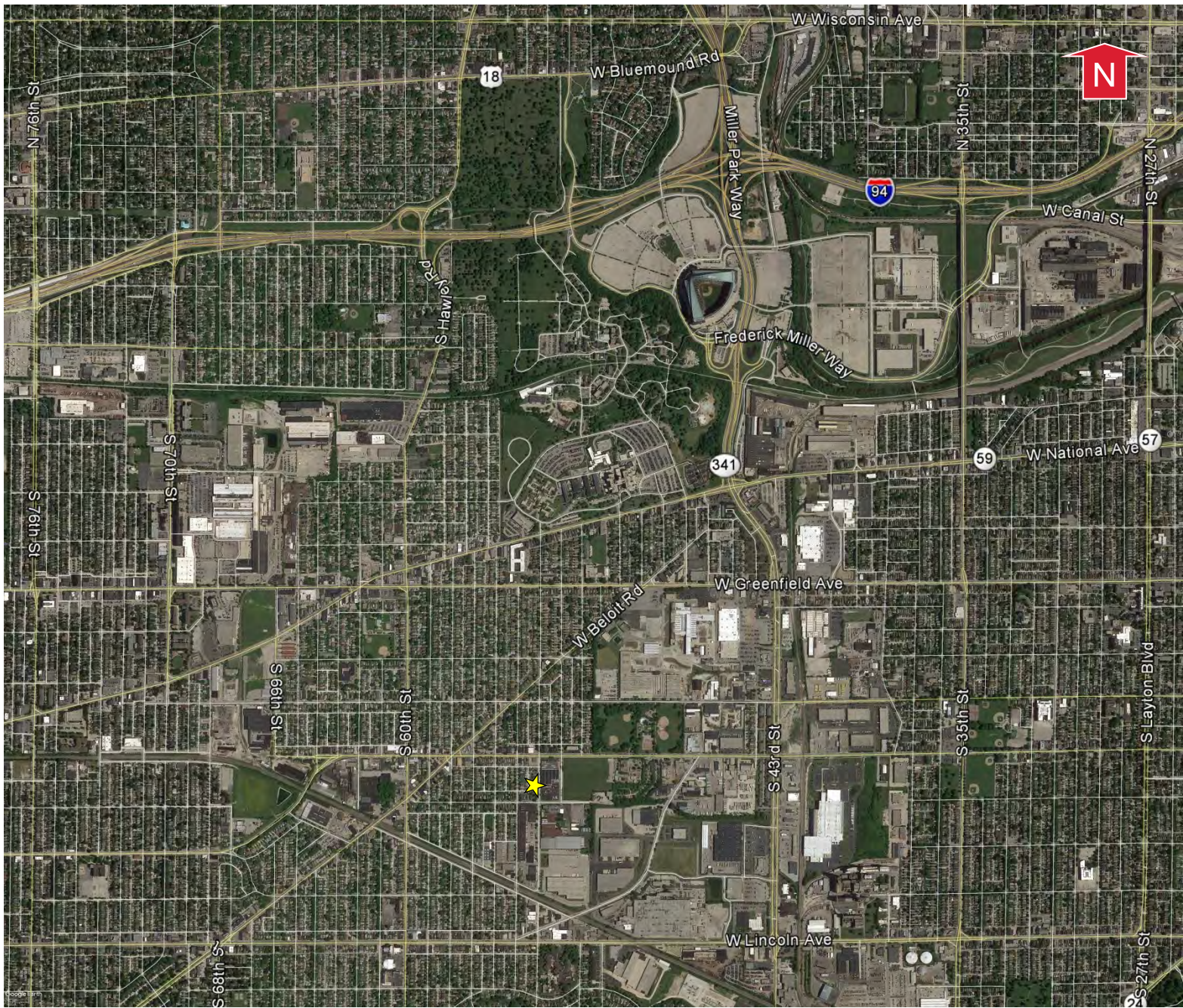

State of Wisconsin Broker Disclosure to Non-Residential Customers
