Map unit: TuB - Troup-Urban land complex, 0 to 6 percent slopes

Component: Urban land (70%)

Generated brief soil descriptions are created for major soil components. The Urban land is a miscellaneous area.

Component: Troup (30%)

The Troup component makes up 30 percent of the map unit. Slopes are 0 to 6 percent. This component is on marine terraces on sandhills. The parent material consists of sandy marine deposits. Depth to a root restrictive layer is greater than 60 inches. The natural drainage class is somewhat excessively drained. Water movement in the most restrictive layer is moderately high. Available water to a depth of 60 inches is low. Shrink-swell potential is low. This soil is not flooded. It is not ponded. There is no zone of water saturation within a depth of 72 inches. Organic matter content in the surface horizon is about 2 percent. Nonirrigated land capability classification is 3s. This soil does not meet hydric criteria.
