Said tract is irregular in shape and is bounded on the northeast by Auditorium Place on the east and southeast by Lafayette Town House on the south and southwest by Tract 8-B (Maurice Heymann Memorial) and on the west and northwest by Girard Park Drive.

That certain parcel of land located in the City and Parish of Lafayette, Louisiana and shown and outlined as Tract No. 18 in that certain plat of survey of Russell Caffery & Associates, dated September 19, 1967. Tract No. 18 is bounded on the Northeast by Hollis S. Altman et al or assigns, on the Southeast by Herbert Heymann or assigns, on the Southwest by Jacqueline Heymann Cohn or assigns, and on the Northwest by Coolidge Street.
