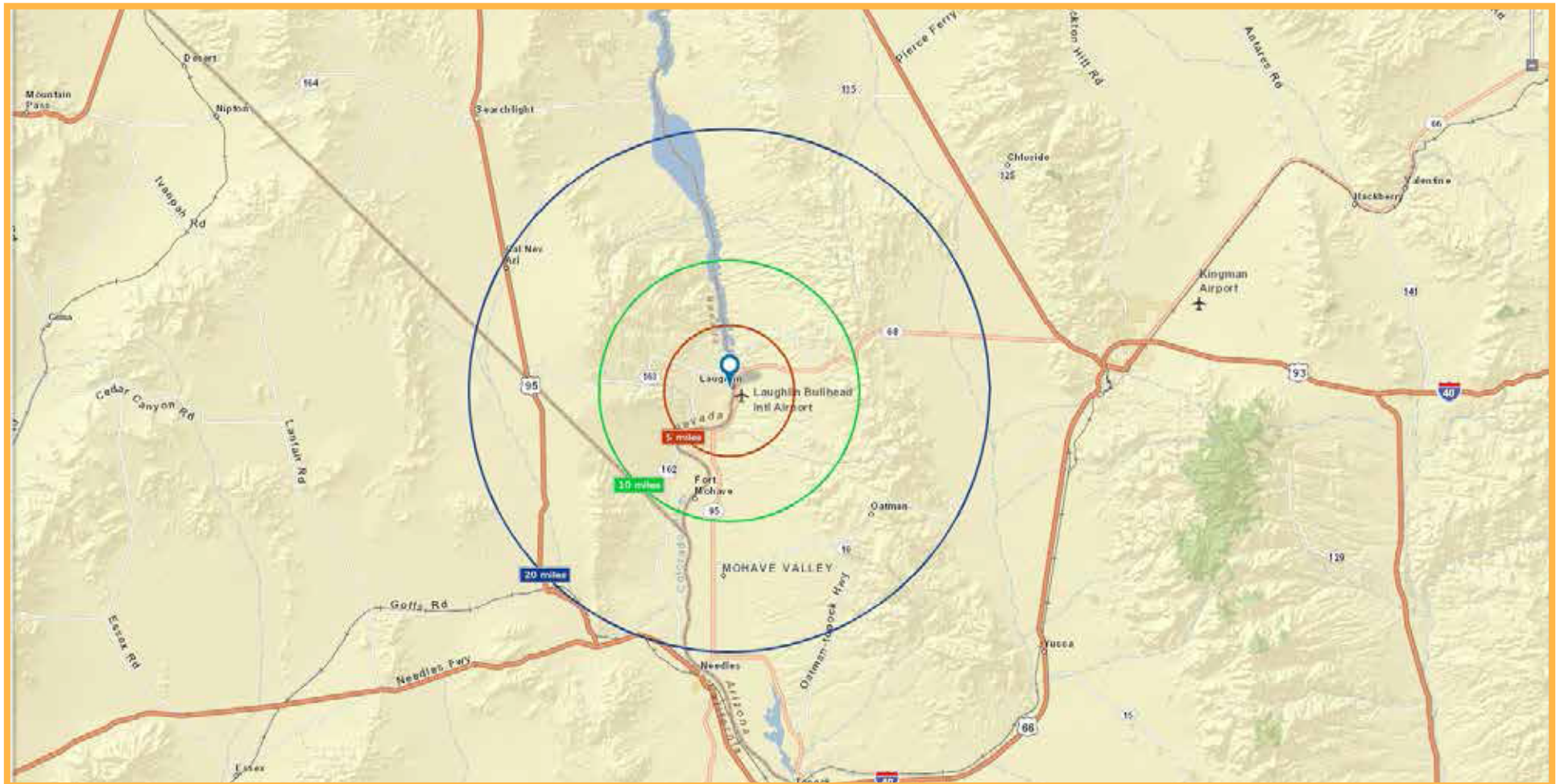
Two-Story Outlet and Retail Center Located in the Heart of Laughlin's Gaming and Entertainment District

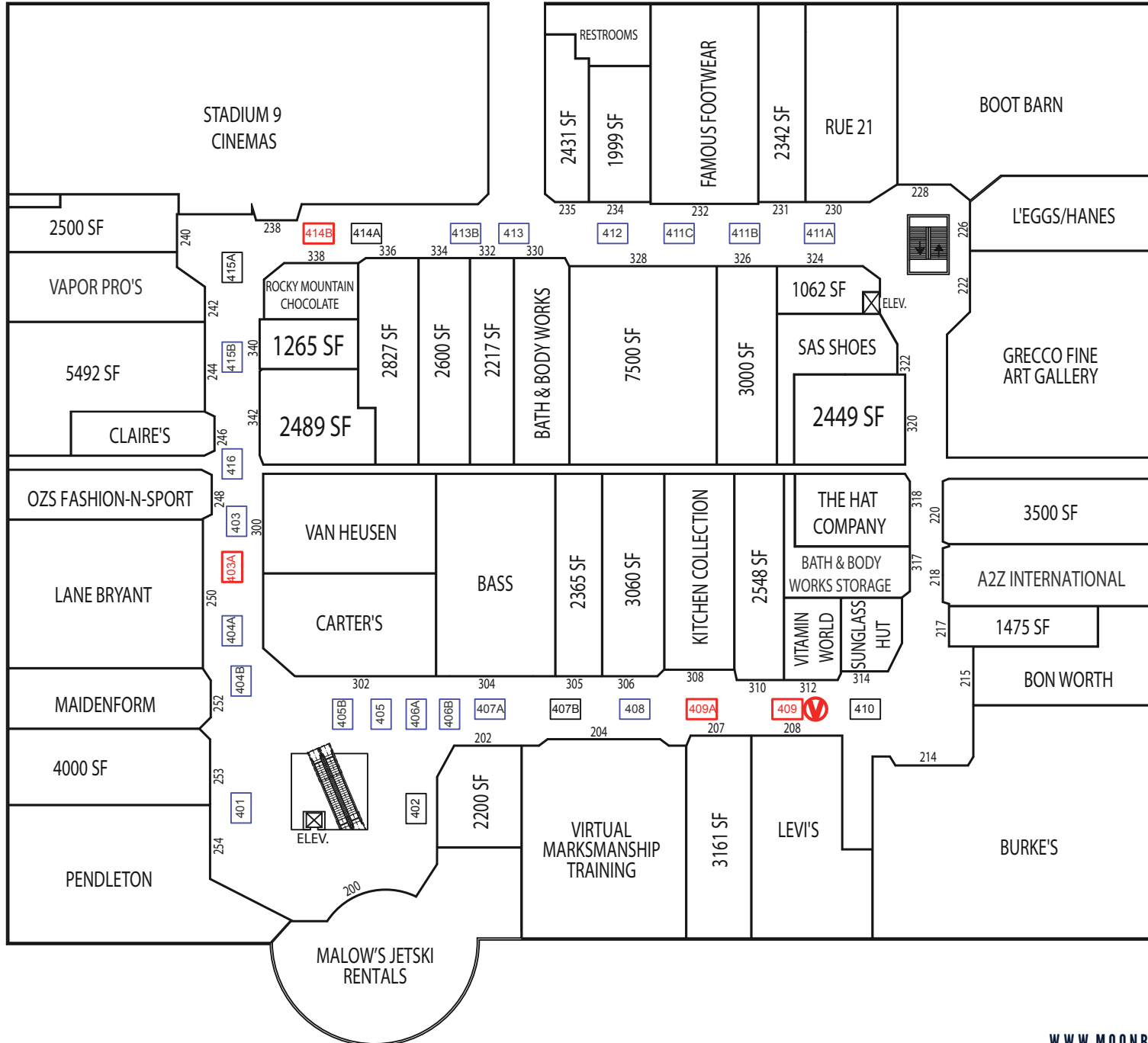


LOCATION OVERVIEW

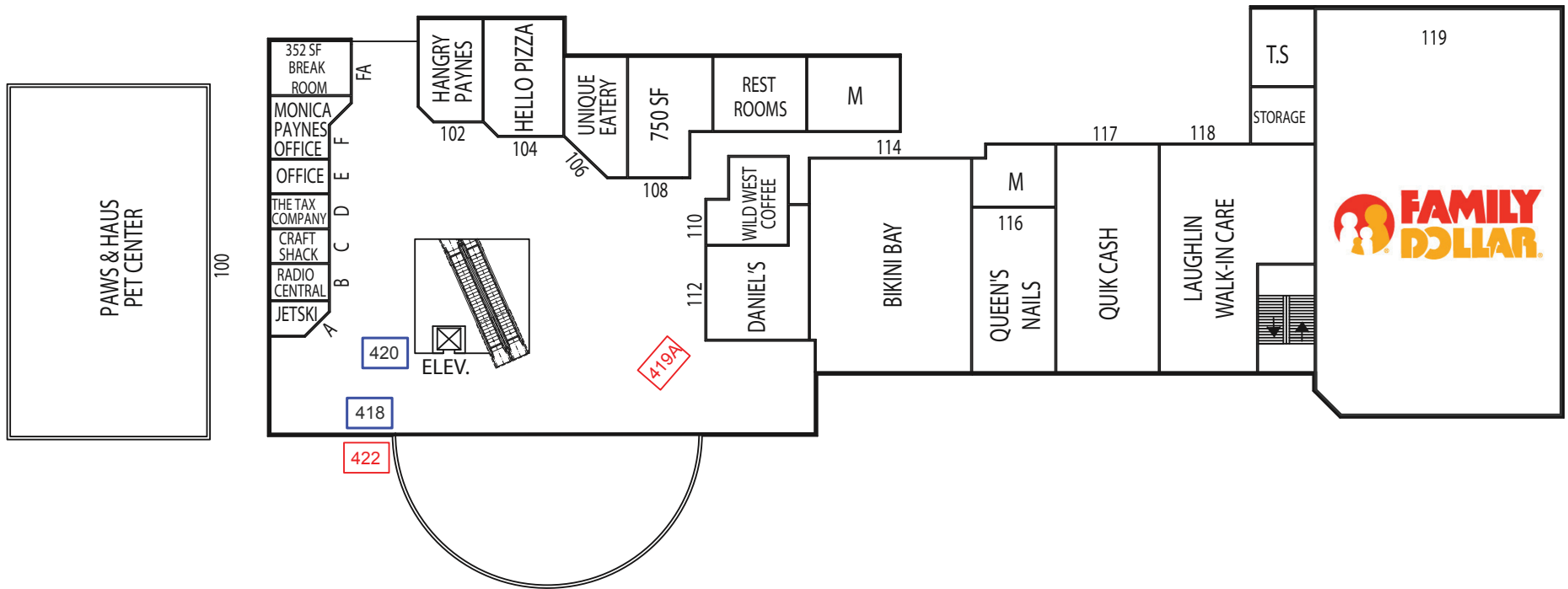
- The center is visible from over 3,100 hotel rooms and within walking distance of Laughlin's 10 casinos.
- Laughlin is a prime vacation destination throughout the year, attracting large numbers of tourists and locals.
- Laughlin Outlets is located 90 miles south of Las Vegas and is the only outlet center within a 100-mile radius.

Laughlin, Clark County, Nevada Growth & Development

- More than 2,000 homes from apartment housing, single family and luxury homes have all been approved for construction in Laughlin. Currently, a multi-million dollar 18-structure housing complex is under construction and could add 900 new residents. The entire project is expected to be completed in 2010.
 - Roadway improvements to expand Needles Highway between Laughlin and I-40 in Needles, CA continue. Also a \$160 million expansion of US 95 between Las Vegas and Laughlin, creating a divided highway with two lanes in each direction, is complete. The much anticipated major trade route offers Laughlin businesses, residents and visitors a safe and quick route to and from Las Vegas.
- Second bridge is under consideration to be built connecting Laughlin and Bullhead and attracting Bullhead residents to Laughlin Outlet Centers.
- A master plan is being created for 9,000 acres of developable land
- Landscape improvement and enhancement of more than 2 miles of Laughlin's Casino Drive totaling nearly \$15 million, a street Laughlin Outlet Center is on!
 - Fort Mohave is adding a new Wal-Mart Super Center.
 - Bullhead City is adding a new Holiday Inn with a waterpark , making a new destination just a short drive from Laughlin Outlet Center.

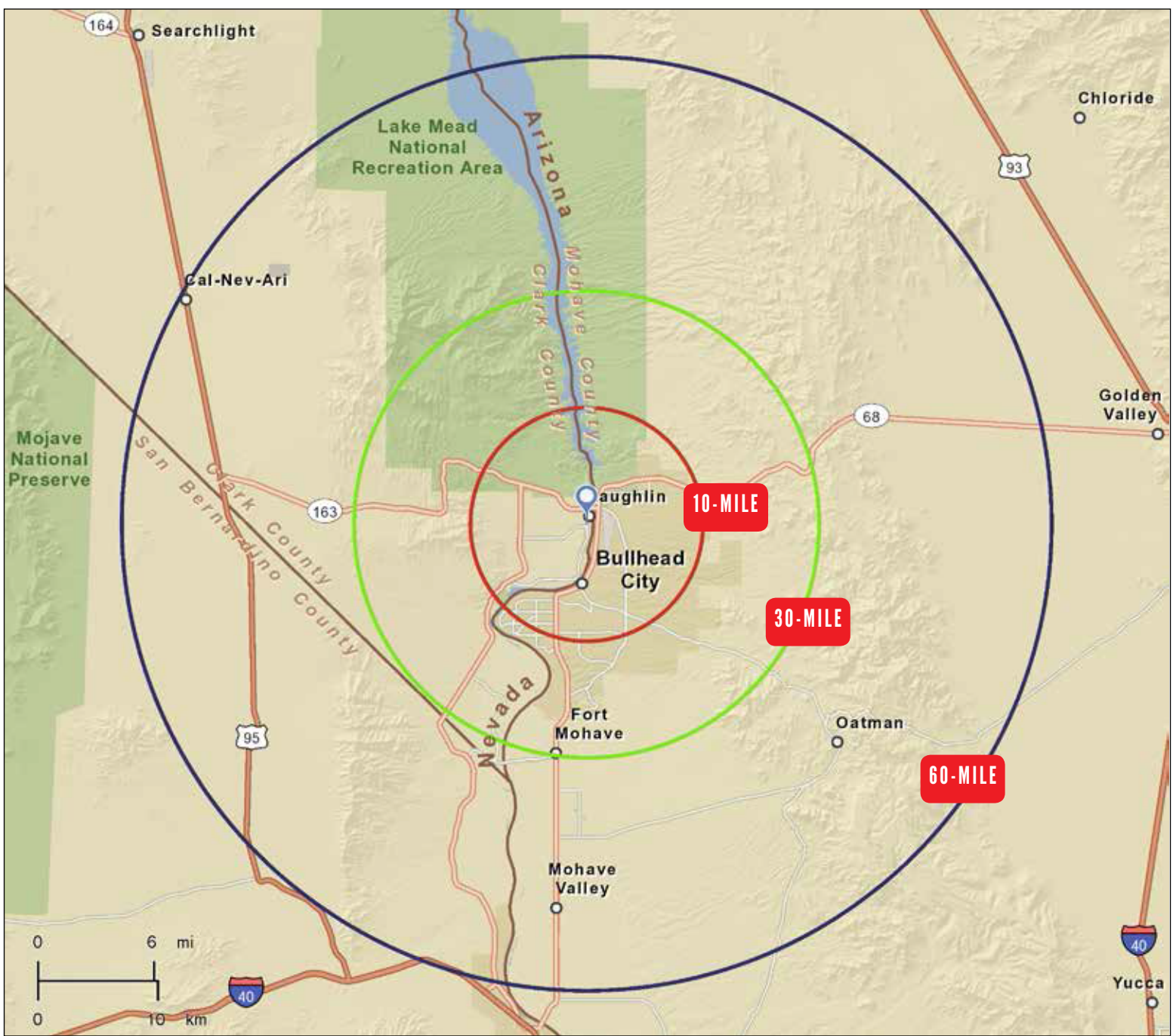

Government Incentive Programs

Nevada is ranked one of the top three places in the U.S. to operate a business because of its tax advantages:

- No corporate income tax
- No taxes on corporate shares
- No franchise tax
- No personal income tax
- Nominal annual fees to incorporate
- Nevada corporations may purchase, hold, sell or transfer shares of its own stock
- Nevada corporations may issue stock for capital, services, personal property, or real estate including leases and options. The directors may determine the value of any of these transactions, and their decision is final.
- No franchise tax on income
- No inheritance or gift tax
- No unitary tax
- No estate tax
- Competitive sales and property tax rates
- Minimal employer payroll tax-0.7% of gross wages with deductions for employer paid health insurance
