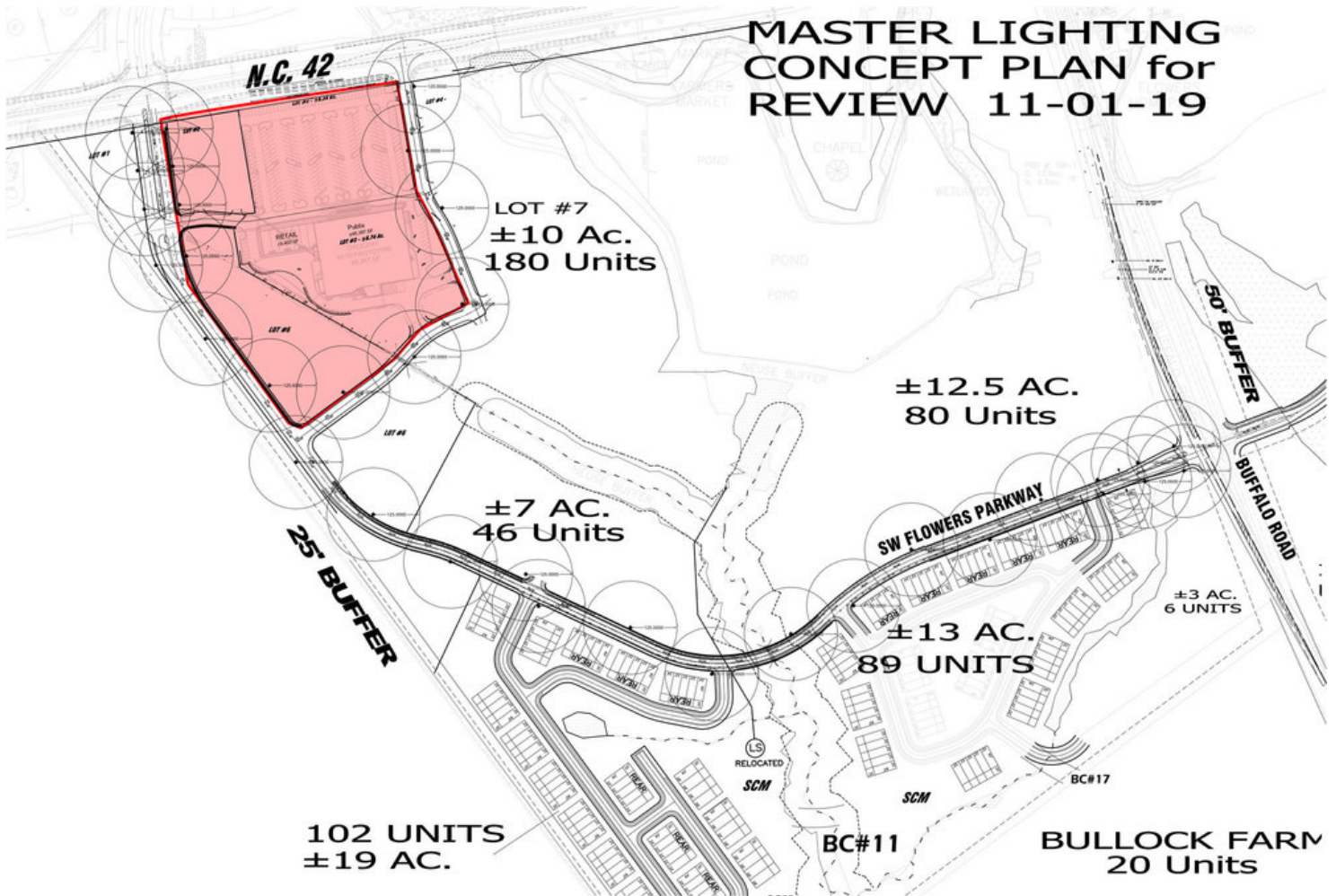
SITE PLAN

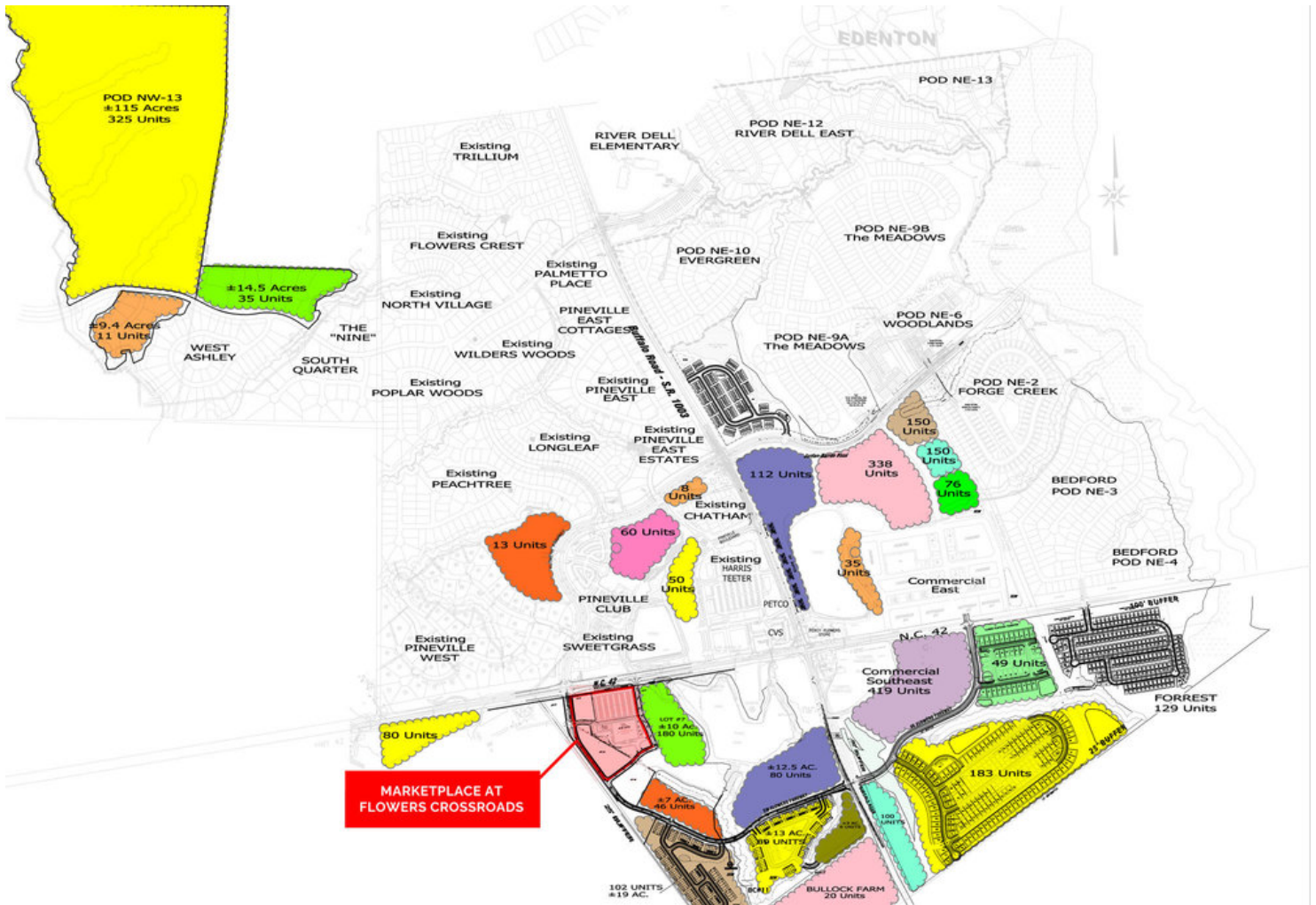
CONCEPT PLAN
