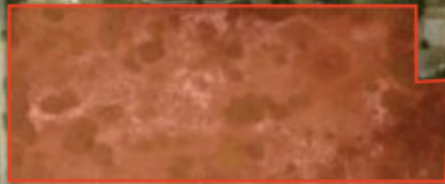

LOCATION DESCRIPTION

The property is located at 3455 Kings Road in Winter Haven, FL 33881. It is at the northeast corner of King Road and Crosstower Drive. It is situated approximately 200 feet north of the intersection of King Road and Winter Lake Road (SR 540) which has a traffic count of approximately 21,500 vehicles per day. The site has 1,142 feet of frontage on Crosstower Drive, approximately 628 feet of frontage on King Road.

Winter Haven is in central Florida with some large employers such as CSX Intergrate Logistics Center, The Landings retail mall, and LEGOLAND Florida, which has become one of the City's largest employers with more than 1,200 employees.

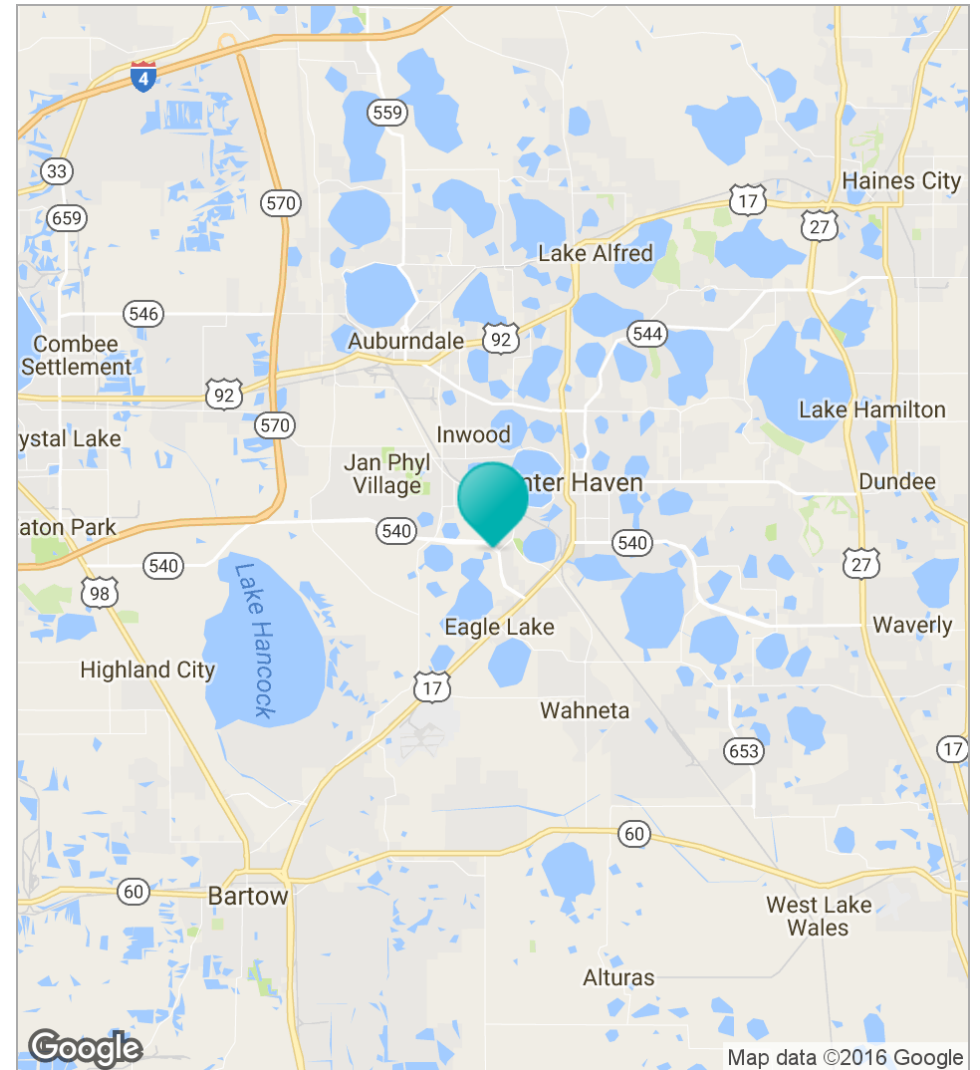
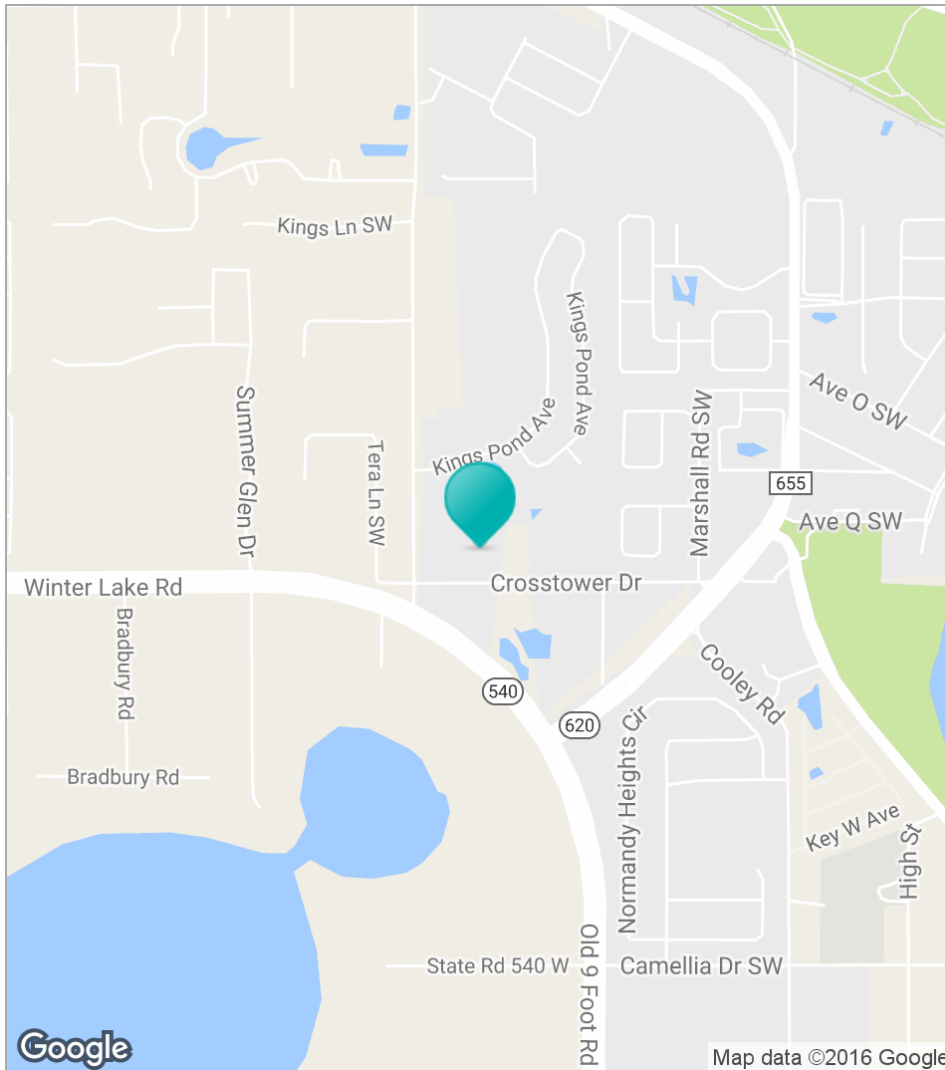

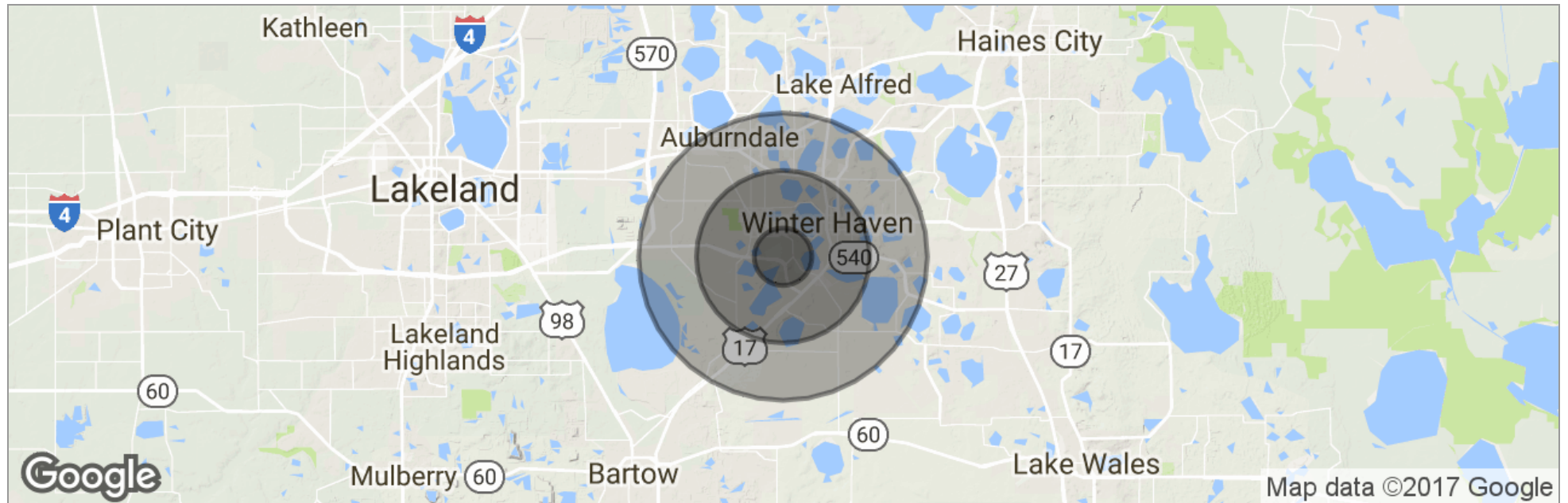
