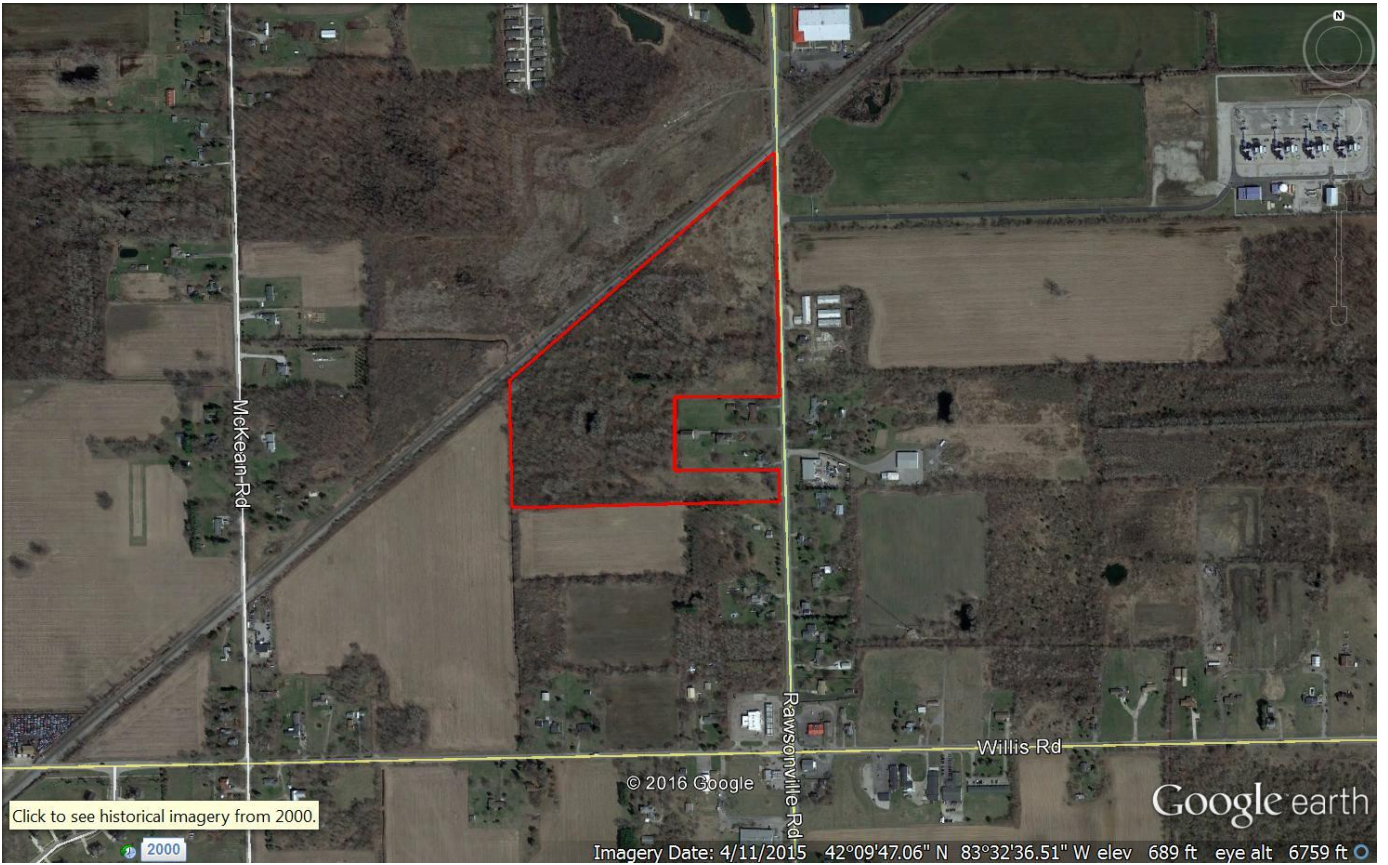

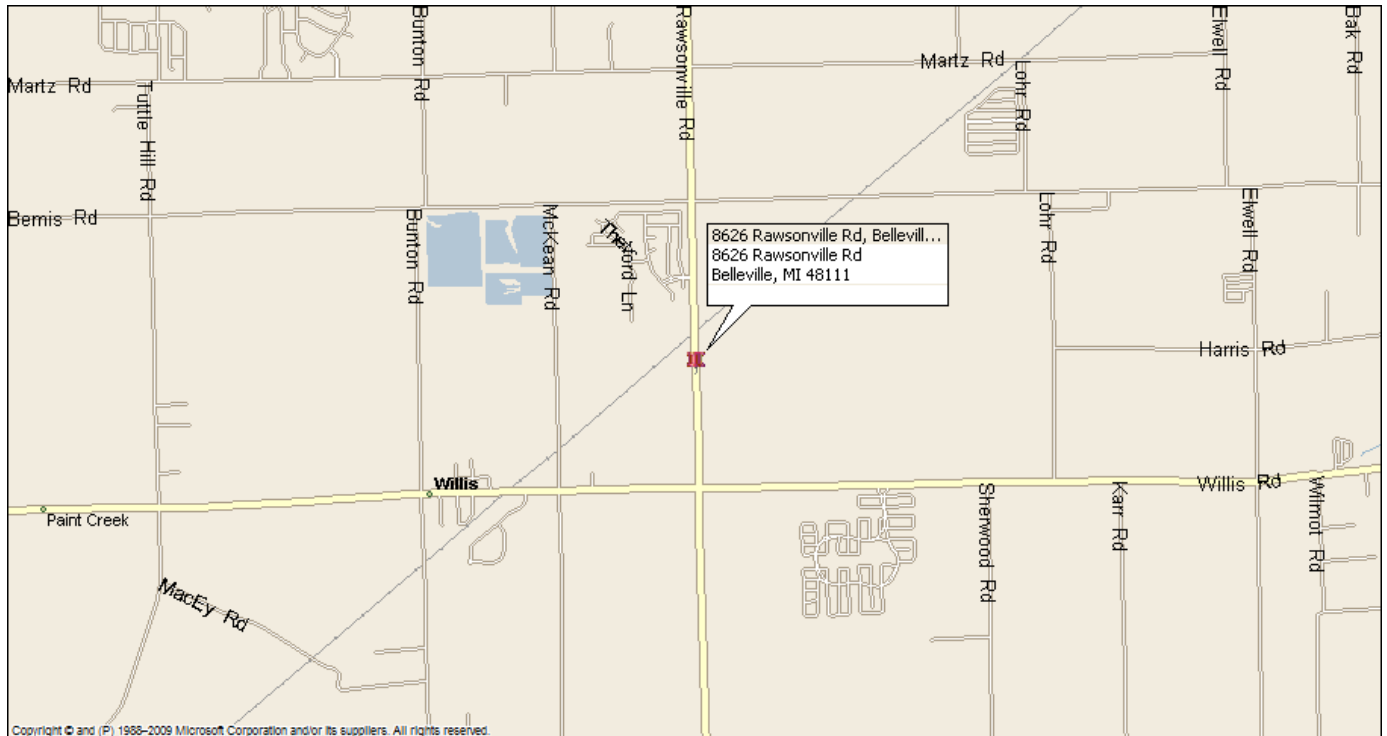

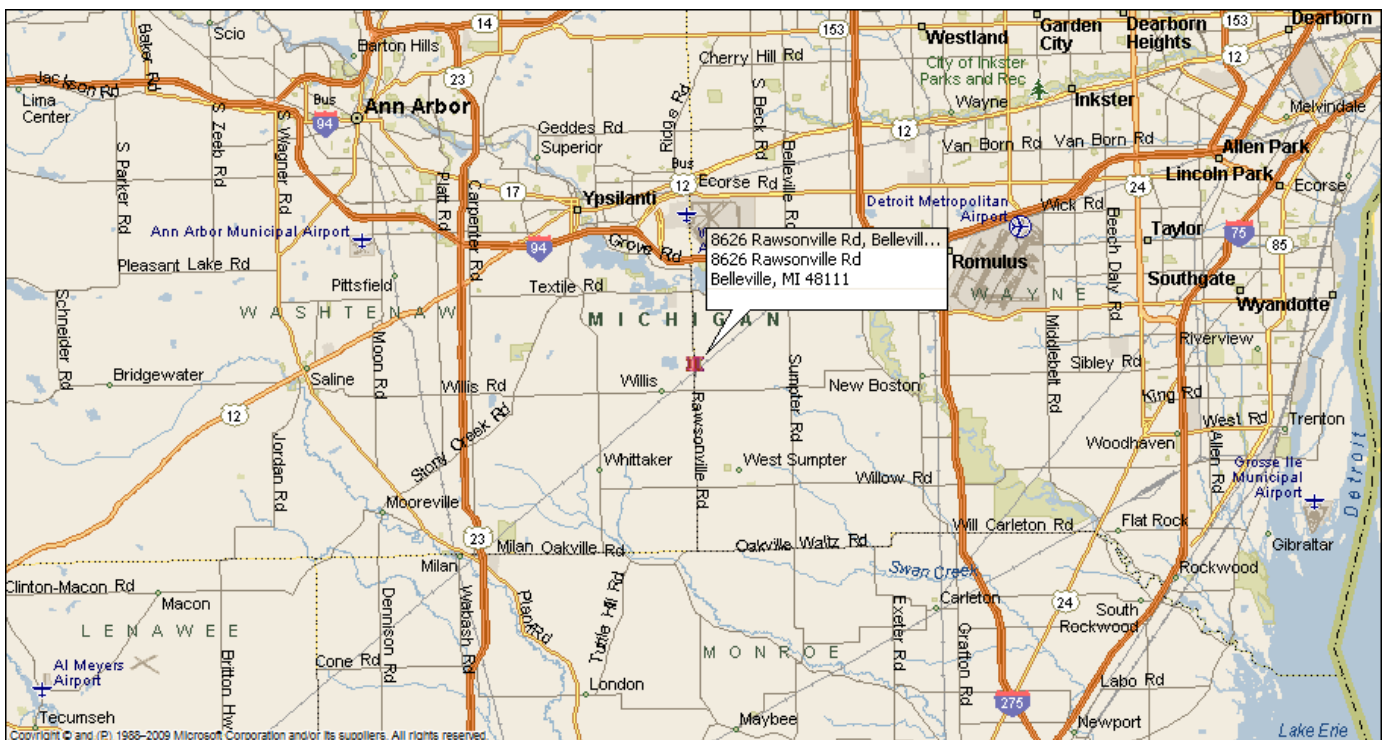

Currently, 65.5% of the 24,661 housing units in the area are owner occupied; 25.5% renter occupied; and 9.0% are vacant. Currently, in the U.S., 55.7% of the housing units in the area are owner occupied; 32.8% are renter occupied; and 11.6% are vacant. In 2010, there were 24,505 housing units in the area - 65.9% owner occupied, 25.3% renter occupied, and 8.8% vacant. The annual rate of change in housing units since 2010 is 0.28%. Median home value in the area is \$151,312, compared to a median home value of \$200,006 for the U.S. In five years, median value is projected to change by 4.65% annually to \$189,889.
