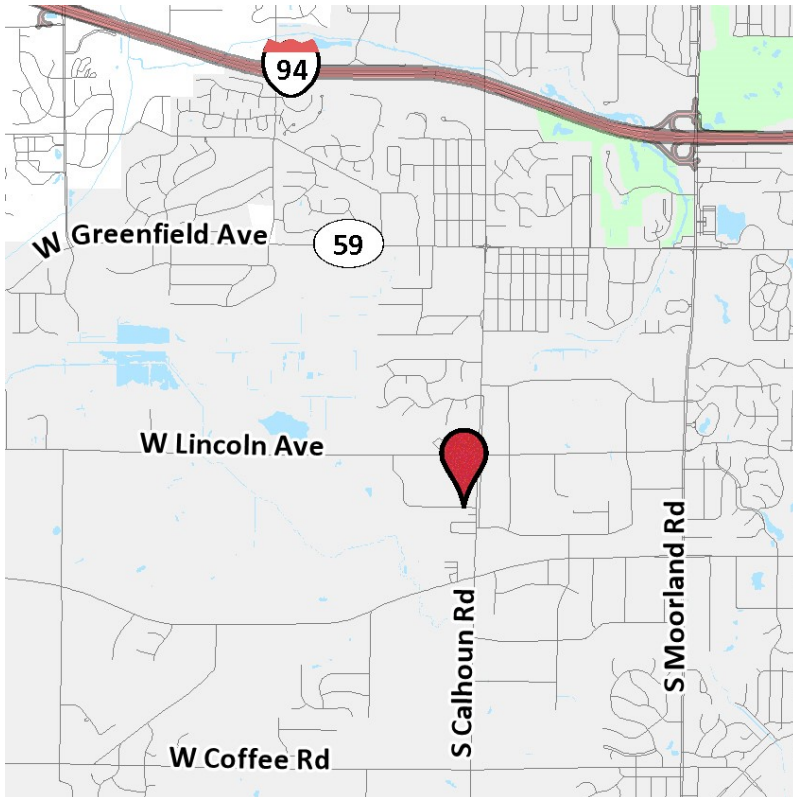

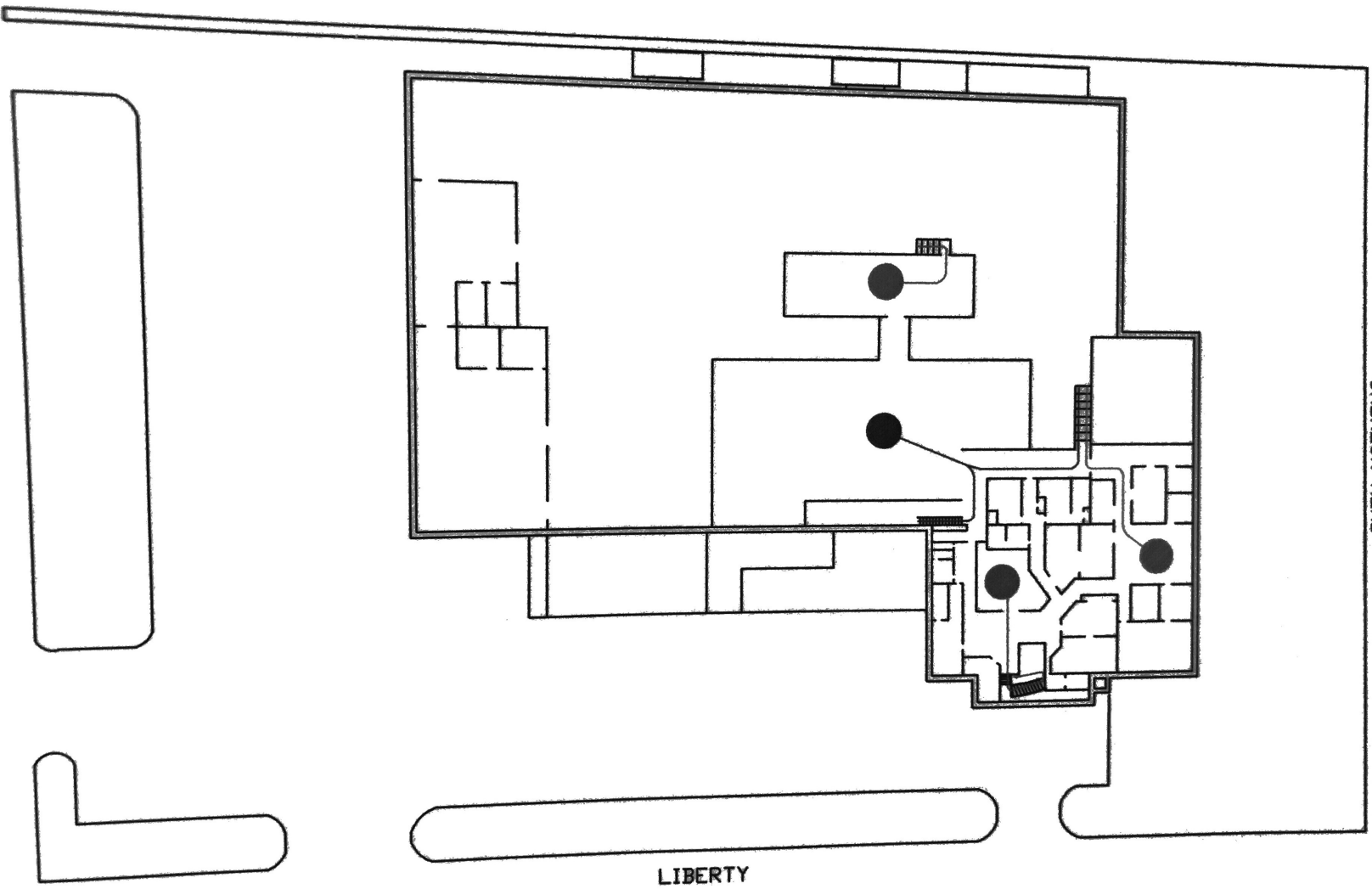

State of Wisconsin Broker Disclosure to Non-Residential Customers

DEFINITION OF MATERIAL ADVERSE FACTS

An "Adverse Fact" is defined in Wis.
