Property Overview


Near the corner of Golf Rd. (Route 58) and Berner Dr., this 35.7 acre site is ready for development. This potential subdivision is zoned R-3, creating the opportunity to develop approximately 75 homes each with a lot of at least 10,000 square feet. Under the current zoning, each house has a maximum floor area ratio of 0.35. The average selling price for homes in the area is more than \$375,000.

Although this site is close to the border with Elgin, it is fully located in Hoffman Estates. This area has seen a significant amount of residential development since 2000, with more than 1,500 residents moving to the area.


