

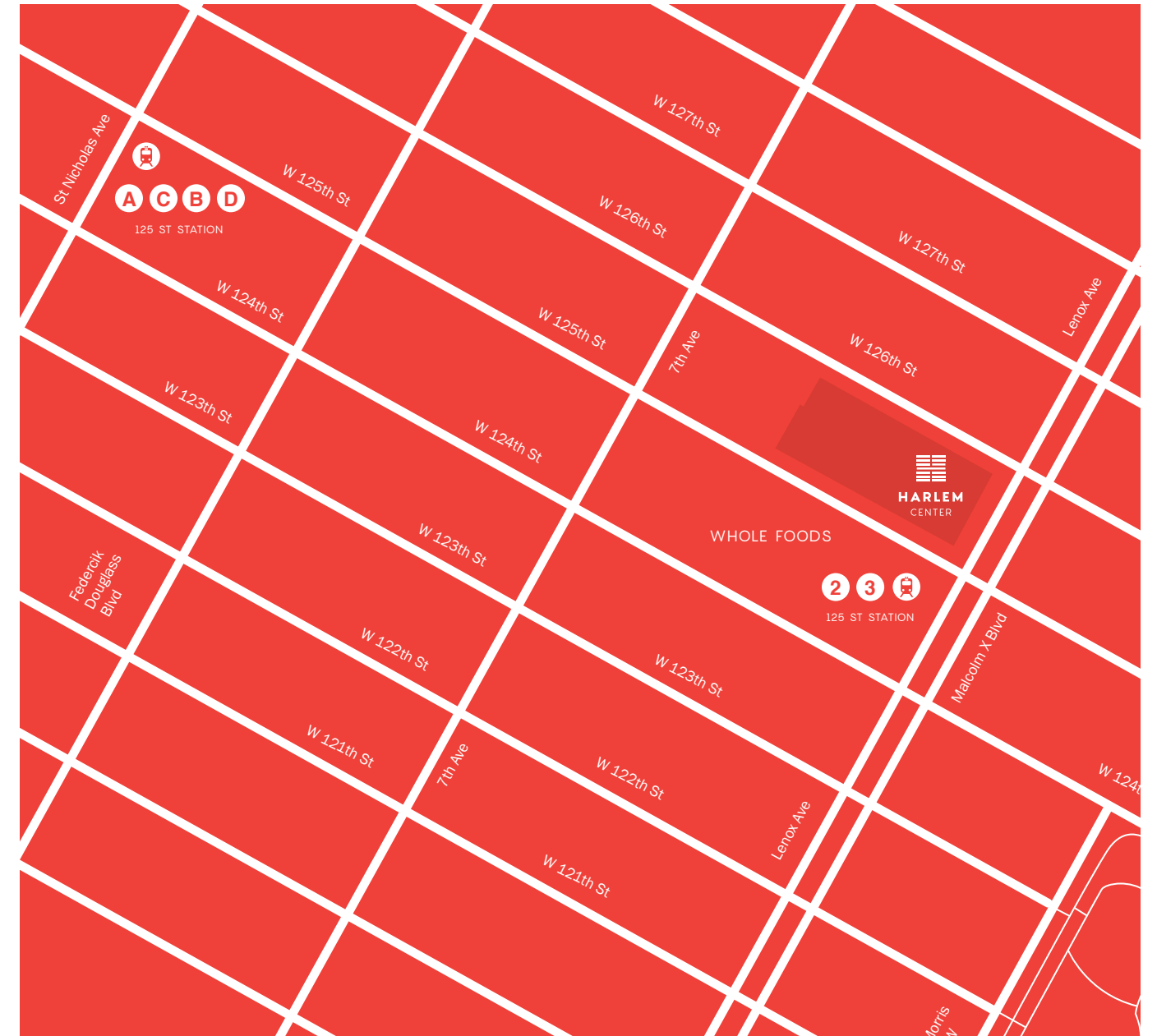
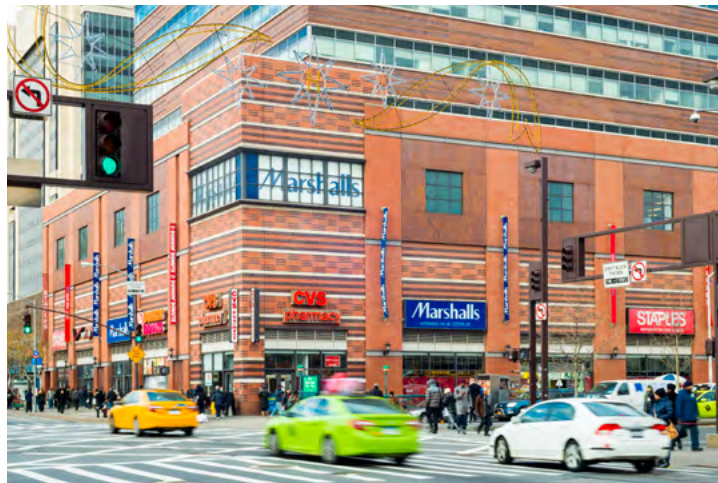
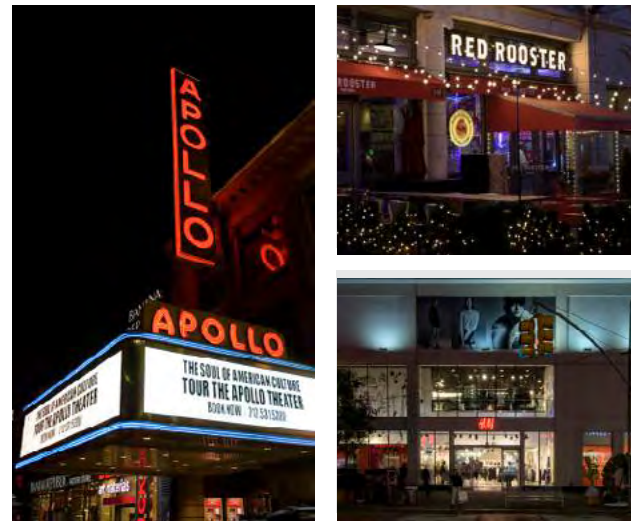

HARLEM CENTER

Harlem Center is a 126,000 square foot urban retail complex located at “Main and Main” on the corner of 125th Street and Lenox Avenue in Harlem, New York, directly across 125th Street from the new Whole Foods. The property is comprised of two separate buildings, with a

mix of national retailers including H&M, Marshalls, Staples and CVS. Harlem Center’s central location draws shoppers from within Harlem as well as other parts of Manhattan and the outer boroughs.



NEIGHBORHOOD

Harlem Center is located in South Harlem at the 50 yard line of 125th Street, Harlem's main retail thoroughfare. The neighborhood boasts a culturally diverse and dynamic demographic with a total population of approximately 350,000 people. Harlem's history is intertwined with New York City, serving as its center of African American culture and home of jazz music. The surrounding area is one of the driving forces behind Harlem's recent renaissance and is home to a unique variety of theaters, shops, businesses, nightlife, dining and the arts.

- Highly productive retail co-tenancy that sits below a 150,000 square feet office tower

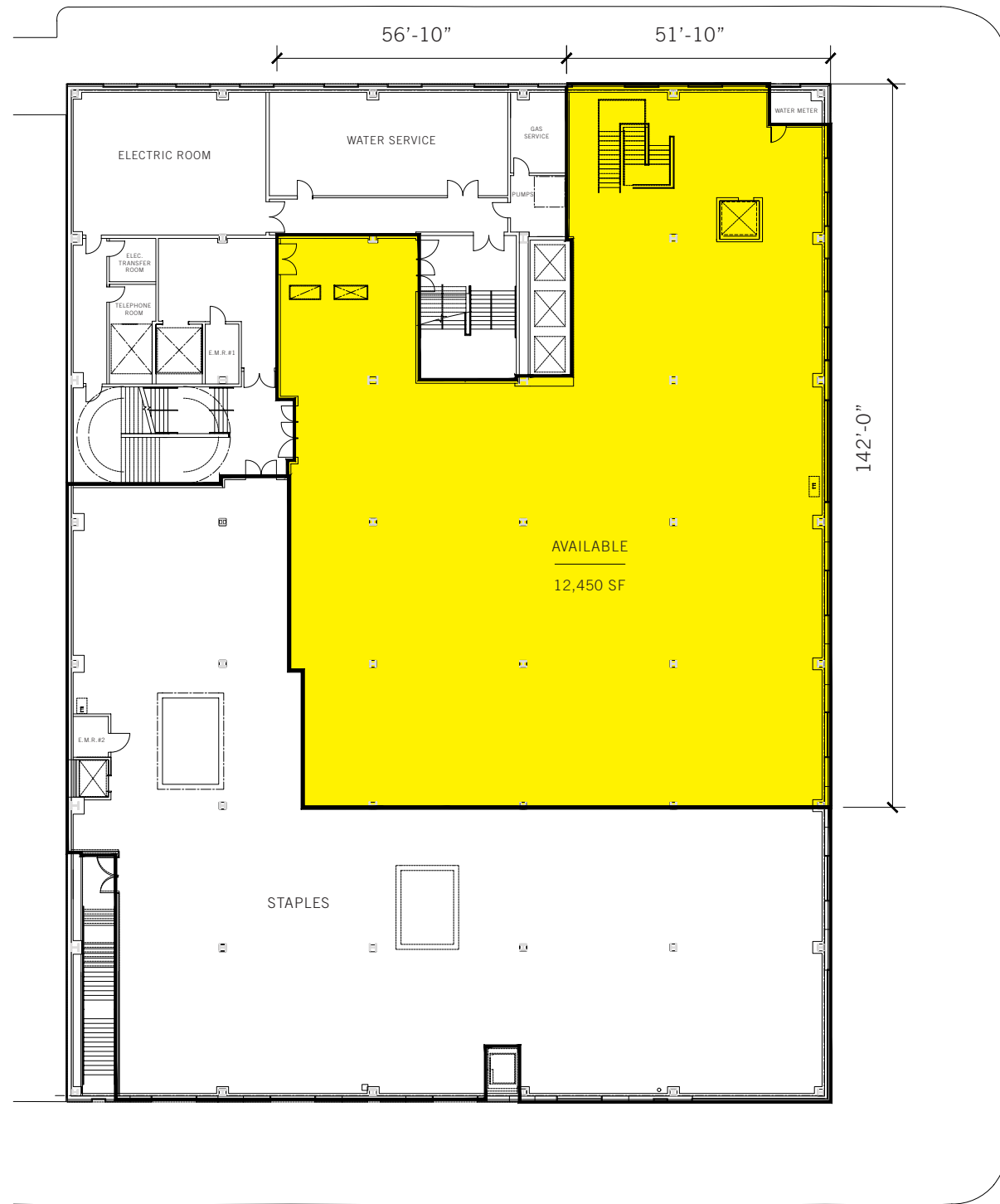
TRANSPORTATION

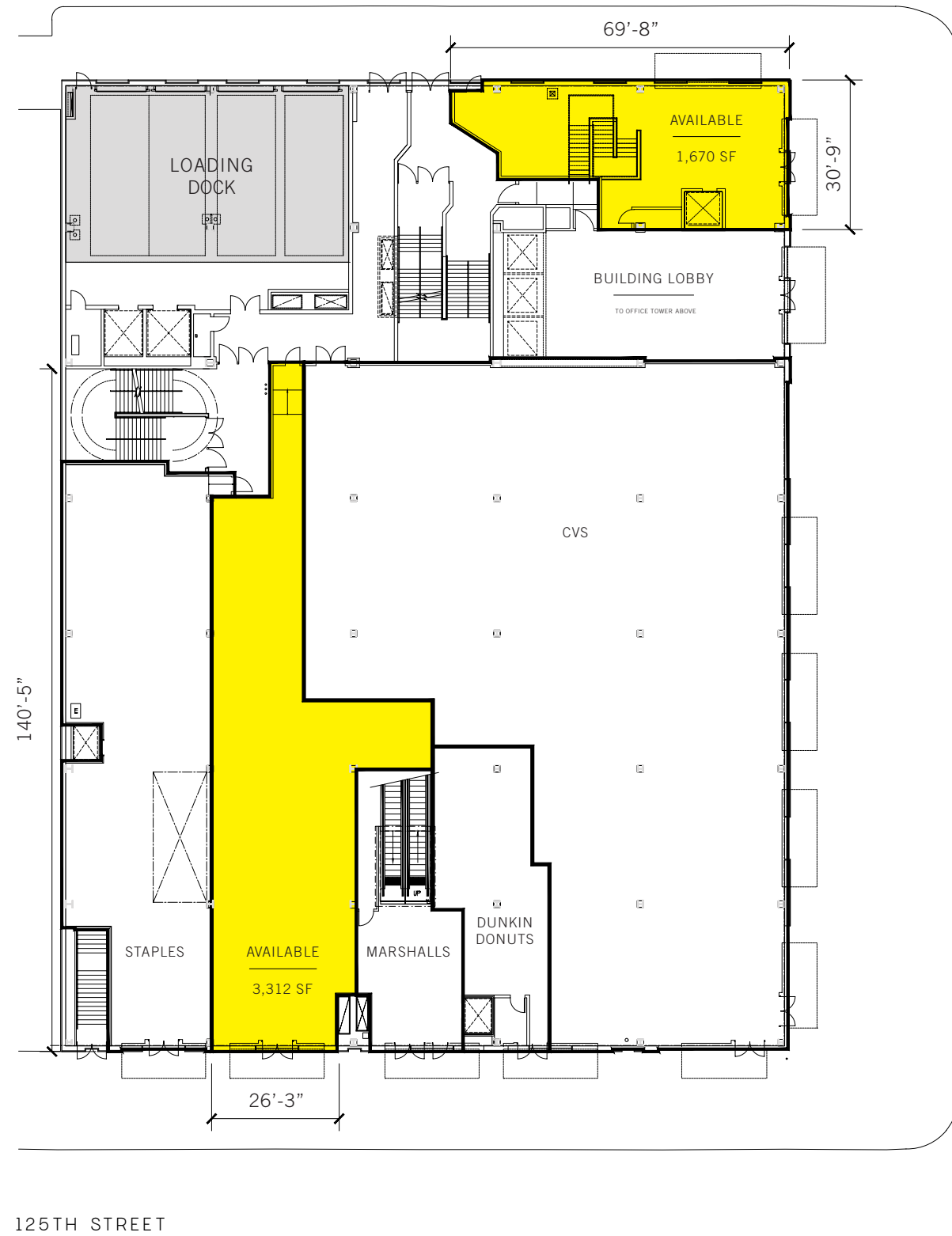
