656-658 Broadway Avenue is an all brick two story commercial building located in the Historic District of downtown Bedford. This historic building is part of the Broadway Avenue Historic District, a commercial area located in downtown Bedford, Ohio. This district area includes 43 buildings constructed between 1888 and 1930. The commercial district was added to the National Register of Historic Places on October 18, 1988.

The building is currently 100% occupied with one (1) retail tenant on the first floor and three (3) occupied apartments on the second floor. The property has had ongoing renovations since 2014. The building totals 2,946 SF with a full basement. The main tenant is Guy's pizza which just signed a 3 year lease and three (3) recently renovated apartments on the second level.

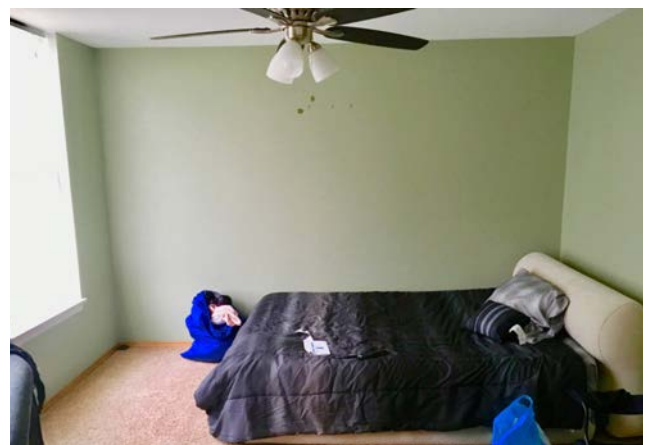
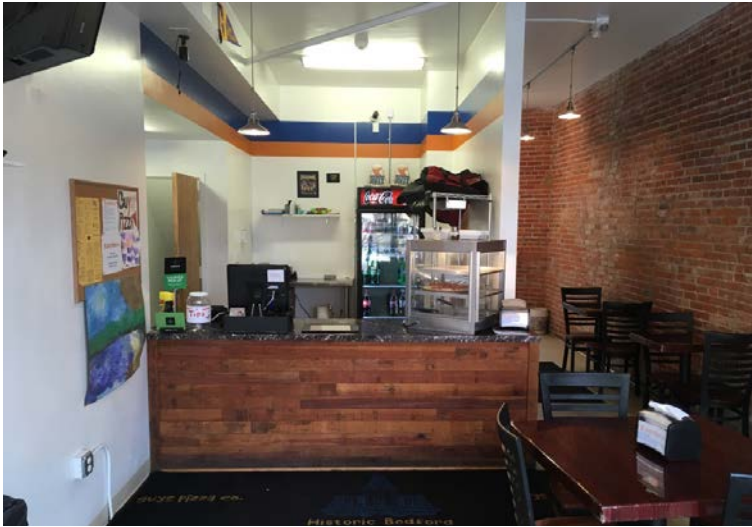
