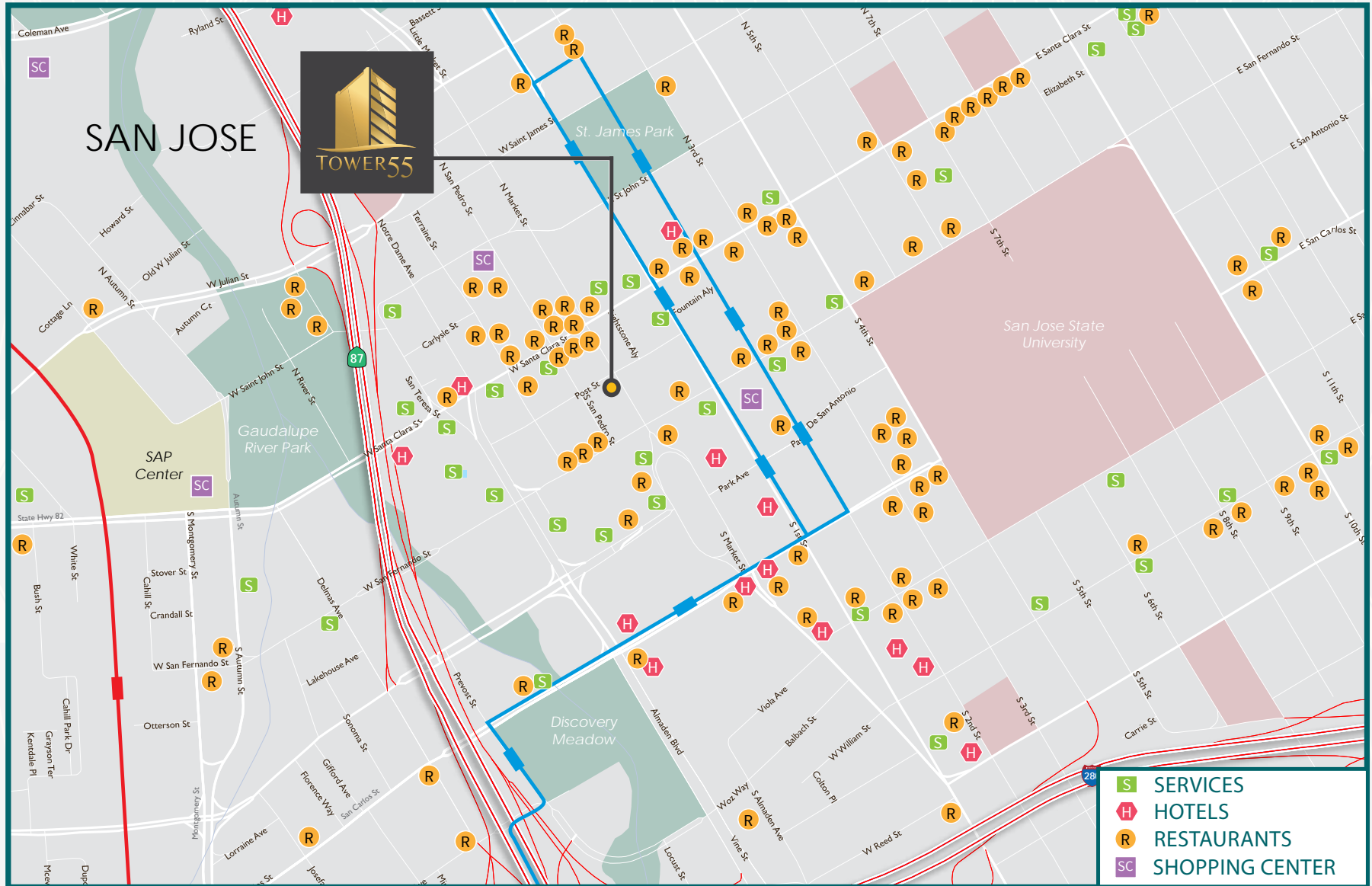

AMENITY MAP



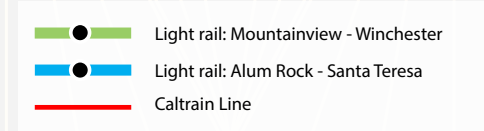
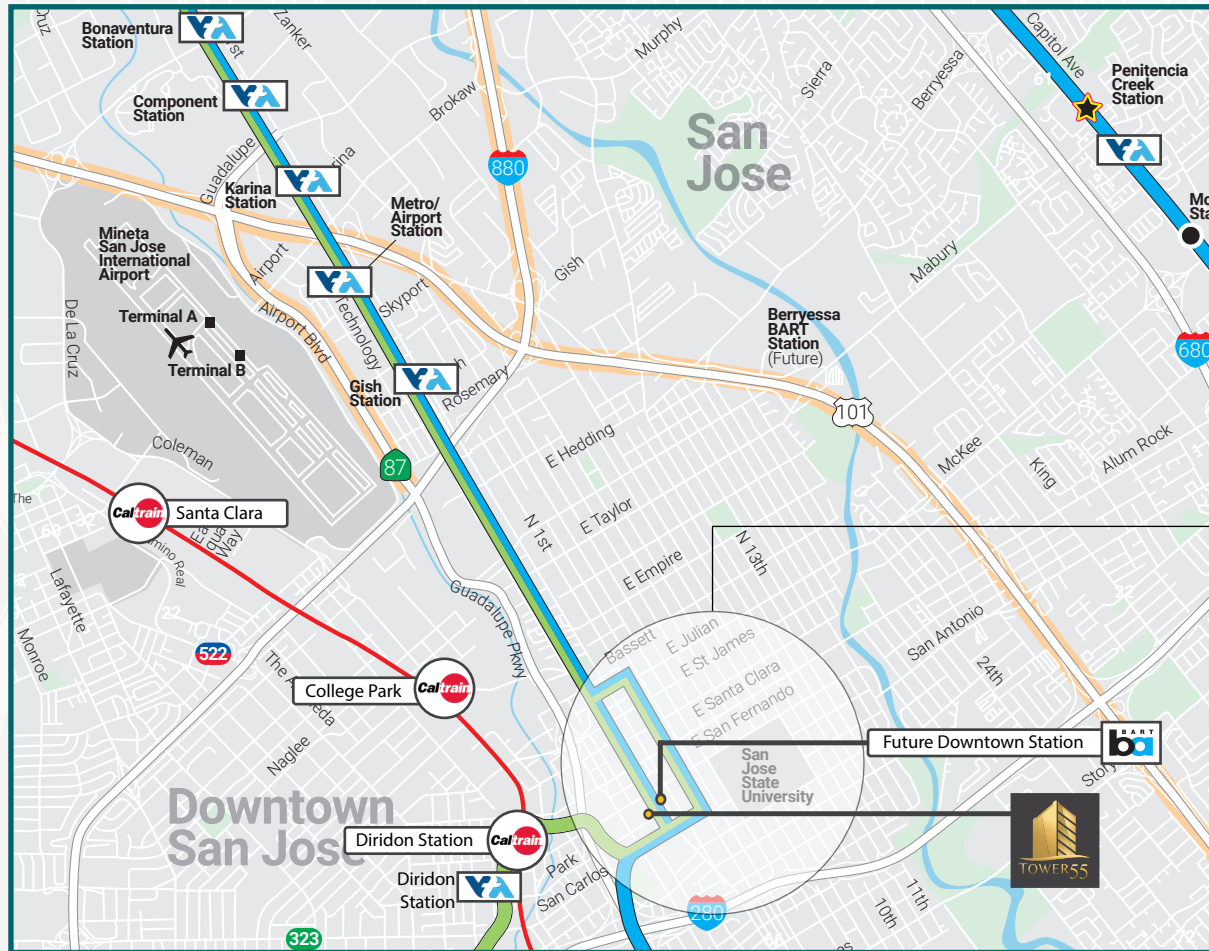

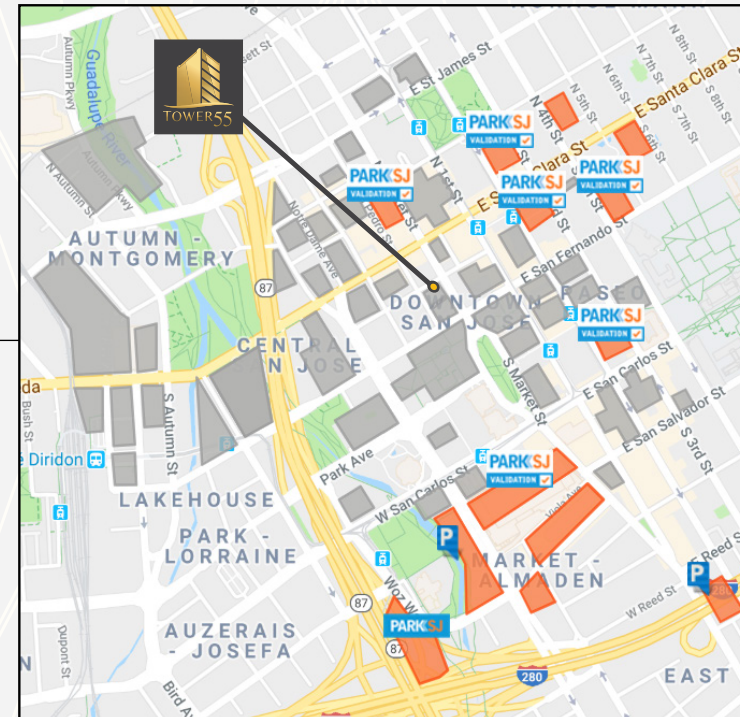


TRANSPORTATION/PARKING MAP

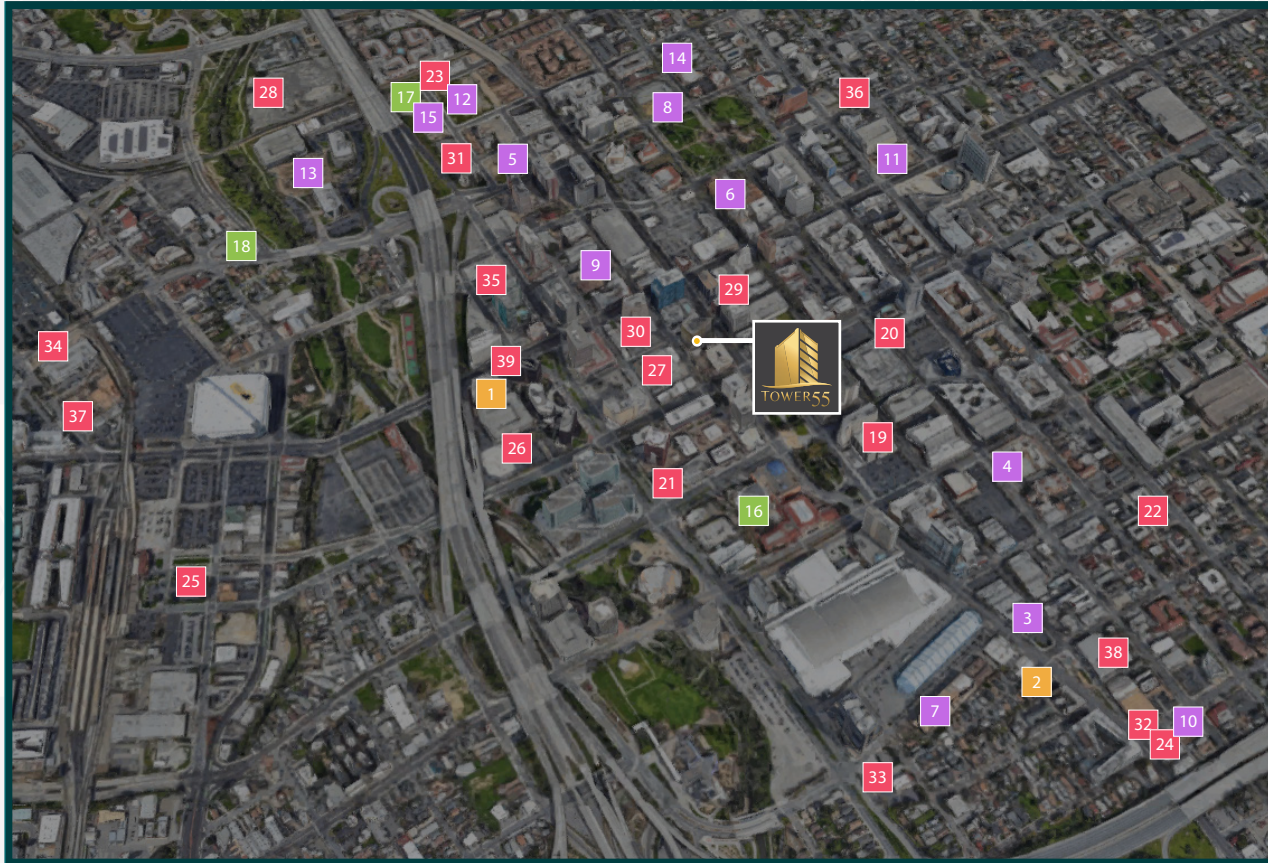

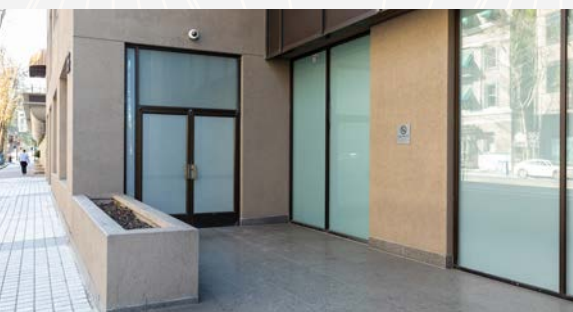

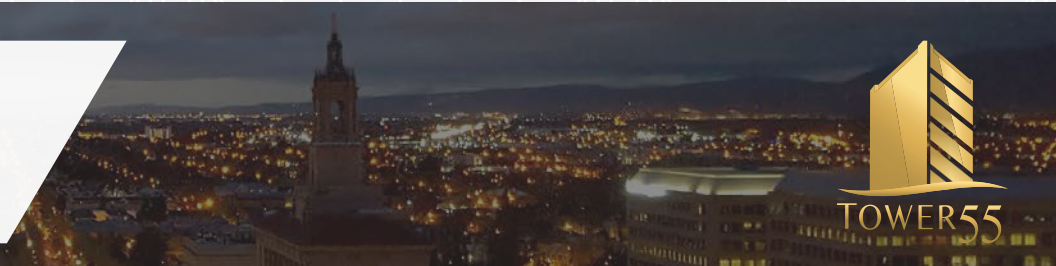
