


# 401 ELLIOTT BUILDING: 84,765 SF













# **Heating and Cooling**

HVAC system with two units mounted on the rooftop. Individual zone terminal boxes are "pressure independent". HVAC cooling capacity allows 2.0 watts per SF for tenant misc equipment loads.

## **Electrical System**

Service configuration of three-phase-four wire service with voltage capacity of 277/480 volts. Service capacity provides at least 15 watts per SF of useable area plus an additional 5 watts per SF to accommodate tenant's needs.

Rooftop mounted HVAC system with two units on 401 Elliott and three units on 501 Elliott. Individual zone terminal boxes are "pressure independent". HVAC cooling capacity allows 5.0 watts per SF for tenant mis equipment loads.

## **Electrical System**

Service configuration of three-phase-four wire service with voltage capacity of 277/480 volts. Service capacity provides at least 18 watts per SF of useable area plus an additional 8 watts per SF to accommodate tenant's needs.
